OTTAWA—John Fox is one of the 16,000 First Nations children taken into care by the Children's Aid Society between the 1960s and the late 1980s to be placed in foster homes as part of what has become known as the Sixties Scoop. On February 16 an Ontario

judge is expected to hand down a decision in the Ontario Sixties Scoop class action case.

The class action lawsuit was put forward by Marcia Brown and Robert Commanda on behalf of themselves and as many as 16,000 other indigenous persons who were part of the scoop, charging that the loss of cultural identity caused significant suffering. The suit was stalled for a year after being certified by the Ontario Superior Court of Justice due to an appeal filed by the federal government.

According to data gleaned from Northern Affairs Canada statistics from 1996, as many as 16,810 treaty status children were adopted out to predominantly non-Native families across Canada, the United States and even Europe.

2016 census report shows Island growth in population numbers

MANITOULIN—Billings is where it's at these days. According to this first release of information released from the 2016 census on population, Billings has the largest of all growth on Manitoulin at a whopping 19.2 percent from 2011 (506 to 603 people). In fact, most Island communities have seen a growth in population with the exception being the majority of Manitoulin's First Nations, where declines are being seen.

Assiginack has seen its population grow from 960 to 1,013, or 5.5 percent; Burpee and Mills went from 308 in 2011 to 343 in 2016 for a growth of 11.4 percent—the second largest of the municipalities; Central Manitoulin has grown by 6.4 percent, from 1,958 to 2011 to 2,084 in 2016; and Dawson-Robinson, Manitoulin's only unorganized township, has grown by 5.6 percent, from 160 to 169-nine people.

Gordon-Barrie Island saw a decrease of 6.8 percent from 526 to 490 while Gore Bay saw a slight increase of two percent, growing from 850 people in 2011 to 867 in 2016. Little Current grew by 8.6 percent, from 1,435 in 2011 to 1,558 in 2016 while its surrounding municipality (of which Little Current is a part but the two are shown as separate entities in the

census report), the Town of Northeastern Manitoulin and the Islands, saw a slight increase of 0.2 percent, from 2,706 to 2,712six people. Tehkummah's population jumped by 7.4 percent, from 406 people in 2011 to 436 individu-

LAKE HURON—Hot on the heels of news that the invasive grass carp (a species of Asian carp) has been found 23 times in the Great Lakes since 2012 (according to a joint report by Fisheries and Oceans Canada [DFO] and the Great Lakes Fishery Commission), the Michigan Department of Natural Resources (DNR) has launched a global challenge to find a solution to the scourge that is the Asian carp. A hefty reward is the prize for a practical solution.

According to the DFO website, "there have been a few rare captures of individual bighead carp and grass carp in the Canadian waters of the Great Lakes. Of the bighead carp, only three specimens have been collected, all in western Lake Erie, between 2000 and 2003, which are believed to have been intentionally released. Of the grass carp specimens, there have been approximately 23

waters of Lake Huron, Lake Ontario and Lake Erie (the most recent one in 2016). Of those tested, nine were found to be fertile. No silver carp or black carp have

Island coffee shops encourage paying it forward

"A customer told me about suspended coffees and I went online to find out more

information," said Loco Beanz entrepreneur Shannon Cranston. "I though it was a really neat idea and signed up online.'

Ms. Cranston said that customers can add to their order, buying an extra coffee and/or a baked good. The 'suspended' coffee or treat is then placed on a special post-it note above the condiment bar (which holds the milk, sugar and napkins).

"Anyone can redeem the suspended coffees," said Ms. Cranston. "In larger urban centres the movement is encouraged to help with poverty and homelessness, but here on Manitoulin I wanted to do it to help with the sense of community and kindness. Anyone can redeem a suspended coffee or treat.

Ms. Cranston's hope is that people will look at the movement as a way to pay-it-forward to their fellow Island community members.

"Everyone has bad days or needs to have their days brightened up sometime," Ms. Cranston shared. "I hope that people use the suspended coffee to cheer up someone, congratulate them on an achievement or give to someone in need of a coffee boost. Anyone can come in, check the board and redeem a suspended coffee or treat.'

"A suspended coffee can be for anyone," states suspendedcoffees.com. "It can be for the homeless man you pass every day on the street, a stressed student in the middle of exams, or a mom who needs a five minute break. It is not up to us to judge who is in need. If someone asks, then they are in need. It helps remind us that no matter how alone you may feel, there is always someone somewhere who cares. Being alone is the scariest thing in the world, and our desire is to brighten those dark days of loneliness and fear. Yes, it's just a cup of coffee, but it's about more than the coffee!

"We just got the promotional materials, posters and cards two days ago and already the board is full, which is awesome to see," said Ms. ranston last Friday.

Will explore ways the violence against male victims underpins tragedy

OTTAWA—The national inquiry into the travesty of the missing murdered indigenous and women and girls has been under fire for both taking too long to get up and running, but a potential sidebar suggesting the inquiry be expanded to include men was (mostly) set aside when the inquiry spoke at a news conference on Tuesday, February 7.

Lead commissioner Justice Marion Buller delivered that message as she addressed issues such as the recent removal of the communications director and numerous questions that have been circulating about the status of the inquiry.

The update came in the wake of criticisms from First Nations leaders, advocates and family members suggesting that better communication would reduce the ongoing trauma uncertainty

generates.

"It's about time," admitted Justice Buller. "We know families, especially, have been waiting for this work for more than a

decade-it is time to get to work."

Lack of drama in Trudeau-Trump meeting promising

He likes us, he really, really likes us! Well, perhaps that may be read-ing a bit much into the first official meeting between Prime Minister Justin Trudeau and American President Donald Trump, but judging by the carefully scripted statements from the two politicians following the meeting at the White House, the historic alliance between our two nations remains sound.

In fact, there were some odd nuances contained in the president's statement—delivered with a complete absence of the off the wall incendiary bow shots that have come to dominate the social media feeds following President Trump's other forays into international pol-

Despite the dire warnings evident in the partisan headlines of the right wing media, Prime Minister Trudeau seems to have held his own during the discussions—or perhaps we are being lulled into a false sense of security, the calm before the storming.

But for this moment at least, President Trump's unequivocal reaffirmation of the historic alliance between Canada and the US, his expression of shared values, our commonality of interests, the intricately woven fabric of our commercial interests and trade, indicate that he has little interest in engaging in a two-front trade war, at least here in North America.

In fact his call for an alliance between our two nations on the trade front to keep jobs here in North America is clearly aimed at calming the jitters in commercial districts of the northern states. As Prime Minister Trudeau pointed out in his statement, also carefully crafted to avoid any diplomatic pitfalls, our two nations engage in \$2 billion in bilateral trade each and every day of the year. It is a relationship that clearly benefits both sides and neither leader has any interest in upsetting that mutually beneficial applecart.

On the terrorism front, President Trump appears to have shunted aside the recent hysteria—factually unsubstantiated—that points to our border as a potential source of terrorist infiltration into the States, in favour of a recognition and affirmation of the close working relationship between our security and border services in thwarting such threats

Although the third party opposition NDP have issued a clarion call

to the prime minister, urging him to tweak the nose of the bully and to stand up for all that is right, just and good, Mr. Trudeau opted for the diplomatic route and an affirmation of those values that both our nations hold dear, particularly in the arena of commerce. "Canadians don't want their prime minister to lecture another country" he said before the meeting. Well of course quite a few actually do want just that. Lectures on pipelines, on refugees and a host of other things they don't agree with. Prime Minister Trudeau wisely eschewed that course as not being in Canada's interests. Sometimes the sensible thing to do may suck, but a responsible leader has to do just that, suck it up and sally forth.

In an almost surreal departure from the crass anti-feminist image that is so often put forward by President Trump and his detractors, the two leaders sat down to discuss the critical importance of the contributions that women make to the marketplace and how to best support and encourage those contributions, although the published text of the president's initial remarks on that subject were peculiarly worded (the better to read in different contexts my dear?), his final remarks on the subject were unequivocal, direct and positive.

Prime Minister Trudeau did not shy away from the fact that we have differences of opinion on a lot of issues, that we do not always agree on every point, but he quite correctly went on to emphasis the importance of the relationship between our two countries and our shared and common interests.

Much has been made of the body language between the two leaders, and Prime Minister Trudeau's boxer-like agility in overcoming the president's odd approach to shaking hands. On that front too, Prime Minister Trudeau proved his competence and made his nation proud. If there are traits Justin Trudeau inculcated from his storied father, they are a solid understanding of preparation and the value of political theatre. A handshake as pirouette.

It may be dangerous to read too much into statements deftly crafted by bureaucrats and read by rote at a podium before two nation's press, but for the moment we have met the "friend," and he is us.

Let us fervently hope it stays that way.

Buyer's remorse sets in on the Sunny Ways

A call to lobby the prime minister to follow through on his electoral reform promise

To the Expositor:

Canadian politics was supposed to be my refuge from the mayhem going on south of the border. Last week I was dealt a blow that has left me feeling jaded and pessimistic. Justin Trudeau broke his promise to reform the Canadian electoral system. Perhaps I shouldn't have been shocked, but I was. When Mr. Trudeau campaigned under the flag of sincerity, compromise (with other parties), and reform, I was enamoured. I was more or less happy to vote strategically in this, the last federal election using the FPTP system, and cast my vote for this noble cause

My feelings of optimism about Canadian politics evaporated last week with the announcement that Trudeau would not honour his promise. He was obviously shame-faced as he sent his new Minister of Democratic Institutions to deliver the news to Canadians. There was a lot of talk about lack of consensus and no decisive model put forward.

This smacks of "alternative facts" put forward to protect Liberal selfinterest. If I was a bit madder, I might even suggest that the PM is lying. The five-month long nation-wide consultation (public meetings, town

halls hosted by MPs, and committee work by an all-party Special Committee on Electoral Reform) found that 88 percent of the public and expert witnesses favoured some form of proportional representation. Canadians overwhelmingly stated their opinion that some changes to the current electoral system would be useful. The committee's job (along with looking at mandatory voting and online voting) was then to weigh the merits of the various alternative voting systems and make their recommendations. The PM favoured the ranked ballot (a non-proportional system) and once he realized that his preference would not be one of the proportional systems put forward, he sacked the committee.

I urge anyone who has ever felt disengaged or disenfranchised from the vote to write to the prime minister and tell him they expect much, much more of him. If a leader gives their word to do something, I expect them to follow through.

Anything less is unparliamentary, self-serving and wrong Most sincerely.



abuse issues. The following is Mr. Fox's recollection of his experience in the Sixties Scoop and the child welfare system in the 70s and 80s. None of the allegations made by Mr. Fox in this story have been proven in court.

The foster placement proved to be the tail of a snake that would plummet him into a life of substance abuse, anger and pain.

"It was violent," Mr. Fox alleged of his foster home experience. "I saw the father beat up the mother all the time. The father was a bully."

Mr. Fox claims that his time in the foster home was essentially one of an indentured worker. "I was a yard worker for them, a child labourer, a farm labourer."

As might be expected, Mr. Fox's memories of his experience poisoned his relationship with the foster family. "They know my views on it," he said. "It was not a good place to learn how to be a parent. My biological sister was placed in the same family."

"I was very fluent in the language, the principal in the school in Wikwemikong used to take me to public speaking engagements. The principal (Sarah Peltier) wanted to tutor me and used to visit me at home."

Mr. Fox may have been fluently bilingual when he left Wikwemikong, but he soon ran up against his foster father, who was hostile to him speaking Anishinabemowin. "He would get really angry and tell me to shut up," he said.

Mr. Fox said his Island placement came to an abrupt end when "I got punched in the face."


He was then transferred off-Island to a foster family in Azilda, his sister went to another family. "We got scrambled," he said. "They sent her somewhere else, I don't know where. We never really connected again."

The Azilda foster home was another experience entirely. "It was a different culture again," he said, adding a different traumatic experience for a 13 year-old. "They were French. I was sent to a French school, everything was very different to anything I had ever known." The stress was palpable.

"I failed every subject in school that year," he said, "even art." His social worker sat him down for a conversation. "She had my report card there in front of her and she was raking me over the coals about it. Whenever I saw a social worker, it was only to badger me. It was never anything good."

It was never anything good." Mr. Fox only lasted in the new home about a year. "One of my foster parents slapped me," he said. He had gotten into a conflict with one of the family's biological children. He made his way

south. "I called the other half of my family in Toronto," he said. Shortly after he moved to live with them. "CAS butted in again," he recalled. "They said I was a ward." CAS paid the going rate for foster parents, but that was the extent of their involvement in his wellbeing, he said. "I never saw my social worker.' The Toronto situation was far from ideal, however, and he eventually had to leave his stepmother's home, again having been there for less than a year. "I slept on a couch and dressed in the bathroom," he said. Soon he began drinking heavily. "I got out of CAS care when I was about 15." he recalled. "I was basically out on the streets of Toronto.' He was on his own. "CAS said they wouldn't do anything for me because I didn't have a place," he said. "What a place to be dumped off without any help. I didn't know anything: how to get an apartment, how to

apply for welfare, I didn't know any of these things."

Wandering the infamous streets of Toronto's 1970s Cabbagetown, Mr. Fox learned the ins and outs of life on the streets. "I called it the Bronx," he said. "I knew all the places, where all the alleyways were, all the safe places to sleep."

A few years later he discovered the Silver Dollar, at the time a favourite hangout for Natives who found themselves adrift in the Big Smoke. Since then the hotel has been gentrified as a jazz club and a music venue of note, and now is being torn down to make way for student housing. But in those days, the Silver Dollar was pretty much a dive known for one thing.

"That is where I learned to power drink," said Mr. Fox. "I learned to drink hard." It was a place where he could fit right in. "Everybody else drank. I was molded for that. I was a prime candidate." A fog descended for the next decade.

"I came to one day and went into treatment; I went for help," he said. It was August of 1986 when his epiphany came with a jolt. "I had been arrested for assault with a weapon," he said. He had plenty of brushes with the law before, mischief and minor assaults, but this time it was serious. "Before it had been small things, but this time I was in big trouble," he said. Not only had he attacked someone, he had also "trashed the place." ty, to learn more about me." He worked as a youth crisis councillor for the Nishnawbe Aski Nation, for Child and Family Services, in Thunder Bay as a clinical youth councillor in a solvent abuse treatment centre.

"Instead of destroying myself, I wanted to help turn others around," he said.

Mr. Fox started one of the first protest actions to bring awareness of the Sixties Scoop to the streets of Toronto.

"I felt strongly about it," he said. "I didn't want the next generation to go through what I went through. It really shaped who I am today."

He credits his older sister, Donna Fox of Wikwemikong, with being a catalyst for his taking action. He found allies in the Council Fire organization in Toronto. "They help people in the downtown," he said. They see a lot of the impact of the Sixties Scoop on the streets every day. "They helped me a lot," he said. "They still help me a lot when I ask them."

That first protest took place at Allen Gardens and there were about 250 people who took part. to go. There should be something available."

Mr. Fox's family has gone through tremendous personal tragedy, his daughter Cheyenne Santana Marie Fox died tragically in Toronto when she was just 20 years-old. Ms. Fox fell from a 24th floor condo balcony in what police have since labelled a suicide, but her family members insist that hasty conclusion just doesn't add up. The only witness to her alleged suicide was a client of Ms. Fox.

While Ms. Fox had a difficult relationship with authority, she is described by those who knew her best as "very compassionate, very caring, she didn't judge anybody."

Sadly, Ms. Fox is too often judged in death, as she was in life, and the insistence of the media in labelling her as a sex trade worker when her story comes to the fore continues to traumatize her family. One of the ongoing legacies of the intergenerational trauma that has assailed indigenous peoples through the centuries.

Ontario Regional Chief Isadore Day says that the federal government's willingness to negotiate an end to the Sixties Scoop claim is a positive sign. However, they must acknowledge to the survivors and to Canada that they have a duty to protect the cultural identity of indigenous children. INAC Minister Carolyn Bennett announced that the federal government wants to negotiate claims resulting from the Sixties Scoop. Unfortunately, the federal government took the opportunity to request that the judge in the case temporarily withhold his ruling, an unprecedented move that brought about an immediate backlash and accusations of cynicism and manipulation on the part of the federal negotiators. The federal lawyers have since withdrawn that request. "The practices of the child welfare system during the period associated with the Sixties Scoop are an ongoing source of great trauma for the indigenous community," said Ontario Regional

Chief Isadore Day. "The current despair felt in far too many of our communities is a direct result of having children taken from their families."

The \$1.3 billion class action lawsuit against the Attorney General of Canada was filed in 2009, on behalf of Marcia Brown, Chief of Beaver House First Nation.

The lawsuit alleges the federal government–with constitutional responsibility, principally through Indian and Northern Affairs Canada–committed "cultural genocide" by delegating child welfare services to Ontario. Approximately 16,000 at-risk indigenous children in Ontario suffered a devastating loss of identity when they were placed in non-indigenous homes from 1965 to 1984 under terms of a federalprovincial agreement.

"I want to lift up Chief Marcia Brown, the representative plaintiff in the lawsuit who led this charge with passion and determination on behalf of the thousands of survivors across the country. Minister Bennett stated that this is a 'dark and painful chapter' in Canadian history that needs to be resolved in order to advance healing and reconciliation. We know that much more healing needs to take place not only for the survivors, but for their children and grandchildren," said Regional Chief Day. "If this government is truly committed to reconciling its horrible historic treatment of indigenous peoples, then the upcoming federal budget must contain sufficient funding and resources to address a multitude of urgent needs," he continued, "we need to address the ongoing suicide crisis with mental wellness programming. We need to break the cycle of poverty and despair with the necessary infrastructure for good homes and clean water. First Nation lives are not lines in a budget or dollar amounts in a lawsuit. All we need are the necessary resources to create happy and healthy communities in order to finally secure our rightful place in Canada."

"They stood me up in front of the judge a few months later," he recalled. "They judge said 'I am going to let you go'." That was 30 years ago.

Since then there has been a lot of challenges, but he has managed to keep his commitment to that judge. "I contribute everything to sobriety," he said. "I went to a lot of self-help groups, did a lot of talking, drank lots of coffee."

He became a social worker, working in Northern communities for the next 20 years. "I went with a purpose," he said. "I wanted to learn more about my identi"There was another one after that, and then another about fivesix years ago that had about the same amount of people," he said. "Allen Gardens has a special meaning for me and a lot of other people who found themselves on the streets. Sooner or later, everyone winds up there."

Mr. Fox said that he was "cautiously optimistic" about the prospects for a resolution to the issues surrounding the Sixties Scoop following the announcement by Indigenous Affairs Minister Carolyn Bennett.

"I want four things to come of this," he said. "One, I want the government to pay the full amount due to the survivors; two, I want to see the child welfare policies for First Nations to change, not just the legislation; three, I want a public apology to all the survivors; and four, I want to see a treatment regime for the survivors. There are still people hurting out there with no where

Artist Mike Cywink looks to crowdsource reconciliation

WIKWEMIKONG—For the past six years Wikwemikong artist Mike Cywink has been visiting schools through the Aboriginal Arts in Schools program, Ontario Arts Council and various school boards, but those avenues can be somewhat hit and miss, dependant on available funding and something of the luck of the draw, so the Anishinabe artist has decided to try a different tack—crowdsourcing.

"I have visited about 35 schools through the program, that's about 3,000 kids that have been reached, but there are another 40 schools that I couldn't reach yet," he said. "So I thought to myself 'maybe GoFundMe can get me to them'."

The artist approximates that his project will take about \$60,000 to bring to fruition. "It takes about \$3,000 a week and about 25 hours a week," he said, adding that, "this is for communities, not just schools."

With tight budgets all around for school boards and the various levels of government, finding the funding isn't always successful each year. By taking that out of the equation, Mr. Cywink anticipates his program can find another route to success.

His Cultural Appreciation from a First Nation Perspective project deals with

themes of the clans, the dodems, historical events, residential school as well as the Seven Grandfather Teachings as students explore a variety of the styles associated with First Nation arts. "I have a lot of artifacts with me," he said. "I have arrowheads and items, some of which date back more than 20,000 years." Mr. Cywink also utilizes the pictographs carved into the rocks by the Anishinabe in antiquity.

Passing on the knowledge of the culture and history of Canada's First Nations is more than an occupation for Mr. Cywink; for many years it has been his life's passion. "I have been travelling to communities up North as a volunteer for the Arts Canada Circle, helping out with Northern reserves," he said. His latest trip was to the community of Pikangikum First Nation, an Ojibwe First Nation located on the 1,808hectare Pikangikum 14 Reserve, in the Unorganized Kenora District of Northwestern Ontario. He has been asked by the OPP and RCMP to return to do a presentation in the school.




Mixed bonspiel trophy decided by a measure

als in 2016.

On Manitoulin's First Nations, Aundeck Omni Kaning saw growth of 1.9 percent, from 365 people in 2011 to 372 people in 2016. M'Chigeeng decreased in population by 1.4 percent, going from 897 people in 2011 to 884 in 2016, Sheguiandah First Nation saw the largest drop of the First Nations communities at 13 percent, going from 154 individuals in 2011 to 134 in 2016.

Sheshegwaning saw the largest jump in population for First Nations, noting a 16.1 percent increase in the 2016 census and going from 118 community members in 2011 to 137 people in 2016. In Whitefish River First Nation, the population decreased by 3.5 percent, dropping to 456 people in 2016 from 487 in 2011.

Wikwemikong, the territory (including all the satellite communities, as well as the village), saw a decrease of 3.5 percent, going from 2,592 in 2011 to 2,500 in 2016 while Wik-

wemikong village saw growth of four percent, growing from 1,291 in 2011 to 1,342 in 2016.

Manitoulin Island as a whole has grown 1.6 percent in the 2016 census, from 13,048 in 2011 to 13,255 in 2016. The Sudbury District saw almost the same growth at 1.7 percent, while Algoma District saw a slight decrease at 1.5 percent. Ontario's population has grown by 4.6 percent this census.

Austin Hunt, mayor of Billings, was pleased with the news that his municipality had seen the largest growth.

"Well good for us," he said. "We've been very fortunate over the years," Mayor Hunt added, noting the amount of summer building the municipality has seen over the past number of years. "This helps overall for tax rates."

Mayor Hunt noted the many volunteer-led community groups who do so much for the Billings community ensuring there are always exciting projects going on in the community which help to entice people to move to Billings, either on a full-time or summer-time basis.

last season. While lack of snow was a factor in last winter's lower numbers, the constant over the past two seasons is the causal factors leading to the deaths, a press release from the Ontario Provincial Police (OPP) states.

OPP investigators are linking the fatalities to riding on unsafe ice, speeding, loss of control, alcohol use and driver inattention, confirming that driver behaviours continue to cause otherwise preventable snowmobile deaths.

In one incident just over a week ago, an 11-year-old girl died after the snowmobile she was driving collided with a transport truck as she attempted to cross a major highway in Iroquois Falls. Another collision claimed the life of one driver and left another in critical condition after two snowmobiles crashed head-on. Last weekend, members of the OPP Underwater Search and Recovery Unit brought to shore the lifeless body of a male driver from a lake, making this the third incident of the season during which a snowmobiler died while riding on unsafe ice.

"The vast majority of these incidents are not random 'accidents' that can happen to just any snowmobiler," says OPP Deputy Commissioner Brad Blair, Provincial Commander, Traffic Safety and Operational Support. "Somewhere along the way, a risk was taken or an error in judgement was made. Sadly, tragedies occurred at an alarming rate over the past two weeks and the only way to prevent them is for every snowmobiler to eliminate all forms of risk when riding."

"As with all recreational activities, there are always risks," adds Lisa Stackhouse, manager, Participation and Partnership Development for the OFSC. "These latest incidents serve as tragic reminders that making smart choices while snowmobiling helps ensure that your journey will be as safe as it is enjoyable."

On Manitoulin, the Manitoulin Snowdusters Snowmobile Club is also concerned with the high number of fatalities associated with the sport of snowmobiling this season.

It tends to give the sport a bad name, as if it is an inherently dangerous activity that should be avoided," says Manitoulin Snowdusters spokesperson Brad Middleton. "That is not the case at all."

"As the information released by the police indicates, most of the fatalities could have been avoided," Mr. Middleton continues. "Those deaths took place due to carelessness on the part of the snowmobile driver or because the driver engaged in unacceptable risks (eg. travelling on thin ice). It was particularly heartbreaking to see the little girl killed in the snowmobile accident near Iroquois Falls on the weekend of February 4-5 while trying to cross a major highway."

"Almost all the deaths have one thing in common—they occurred at a location other than on a groomed OFSC trail," he continues. "If you buy a trail permit, and use the official trail system here in Ontario, your chances of being killed or seriously injured are almost nil."

"The Manitoulin Snowdusters are particularly proud of our safety record," Mr. Middleton adds. Since the Manitoulin Snowdusters became affiliated with the OFSC governing body in 1991 and the trail system was installed on the Island, there have been no fatal injuries due to snowmobiling on Manitoulin.

Contrast that to the decade before. In the 1980s, there were at least four deaths relating to the operation of snow-mobiles on Manitoulin.

"That is why it is so important for all snowmobilers to get behind the local snowmobile club so we can continue to offer an infrastructure that is both safe and extensive for our sport," Mr. Middleton states. "That is also why we seek the cooperation of private landowners to grant land use permission to enable a trail system that promotes safety."

Mr. Middleton also reminds parents that the legal age for driving a snowmobile—other than on private property—is 12-years-old and even then young people are required to take a driver training course and be issued a snowmobile driver's licence.

The snowmobile driver's licence course has not been offered on Manitoulin yet this winter but according to the Snowdusters, a course may be arranged for youth in late March.

The website goes on note that juvenile grass carp have been found in the Sandusky River in Ohio, which empties into Lake Erie. These fish are said to have been produced by natural reproduction.

Joanne Freeman, invasive species communicaers built to prevent Asian carp from entering the Great Lakes through the Chicago Area Waterways System, according to the Michigan DNR website. Should the fish make their way through those barriers, it would be devastating to the Great Lakes eco-system and could mean the end of a \$7 billion fishing indus-

The Michigan DNR has partnered with InnoCentive—a global crowdsourcing leader that has undertaken more than 2,000 projects crowdsourcing across the world. "This helps us ensure valid responses, Ms. Fo eman explained, "and this is how solvers can access the challenge." The InnoCentive page for the Michigan Invasive Carp Challenge is not yet up and running but until then the DNR encourages 'solvers' to register on the Michigan DNR website (michigan.gov/carpchallenge). They will be

informed once the InnoCentive page is ready for their submissions—likely this summer.

In the meantime, Ms. Foreman said she and the rest of her team will be spreading the word on what can be done and what has been done to help stop the spread of Asian carp on both sides of the border, and all the complexities invol tha The Michigan DNR has not yet decided on an end date to the challenge. tions coordinator with the Michigan DNR, explained that the 'Michigan Invasive Carp Challenge' came out of Michigan Governor Rick Snyder's 'State of the State' address in January. In the address, the governor promised \$1 million toward the global challenge (yes, Canadians can enter) to find a solution, or solutions, to stopping the spread of invasive carp in the Great Lakes.

As we now know that grass carp have found their way into the Great Lakes basin, Ms. Foreman said she hopes the challenge finds solutions to dealing with the big head and silver carp—the most voracious of the Asian carp species when it comes to feeding and reproductive capacity. These two species are now living within 16 kilometres of the three electric barritionally introduced into farmed catfish enclosures in the southern United States in order to assist catfish growers by cleaning these commercial ponds. Escapees made their way into the Mississippi River and its tributaries and are now close to Chicago and perilously close to Lake Michigan.



"When we first started this project, there really wasn't any passion, as such," she explained. The team were all students looking for a winning concept for a school project. "It started in 2015, we were looking for a documentary subject that was timely." None of the project team are indigenous themselves, she explained.

But as the project moved forward and the team interacted with the family members of Ms. Cywink, the subject matter began to take firm hold and passion grew.

As is fitting for an Anishinabe subject matter, that passion took the form of a familial connection. "As we got into the project, we really connected with the Cywink family. A we got to know Meg and Alex (Cywink), Sonya's family members, we became a part of their family and they of ours," she said. "It was what really drove us to complete this project."

Asked what the team wanted most highlighted

in this report, Ms. Tse said that she and the team members wanted it stressed that 'Shades of Our Sisters' is a "family first collaborative project. Everything has been done in direct collaboration with the families," she said.

The exhibit will include

the two documentaries on Ms. Cywink and Ms. Carpenter, telling their stories and putting faces to the impersonal numbers behind the more than 1,200 missing and murdered. There are also two art installations pieces ("like what you would see in a museum," supplied Ms. Tse) and a new installation that has grown organically out of the project—'Feathers for Women.'


"We contacted schools and communities across the country to fill out a questionnaire on their feelings about violence, and to contribute feathers for a mobile we are creating," she said. "We originally hoped to collect 1,200 feathers, but we have already reached that goal."

The embarrassment of riches encompassed in that success presents a wonderful challenge. "We have to figure out how we will construct the mobile and transport it to the installation sites," said Ms. Tse. "It's pretty big right now."

Shades of Our Sisters will be exhibited in this

coming Friday, running February 17 to 18, in Toronto at the Ryerson Student Centre, then will travel to the home communities of the two women profiled in the exhibit, Ms. Carpenter's home community of Andersonville for two days before arriving at the Espanola High School on Friday, February 24 and to 25 from 6:30 to 8 pm. The official notice of the exhibit reads "attendees will be transported into the grief, laughter and love of two families sharing who their loved ones are and what the loss of their life means, challenging Canadians to realize the injustice of this national tragedy."

...continued on page 3 low commissioners understand and share many of the frustrations being expressed by the families, "we also know we have to do the job properly—and that takes time."

The national inquiry will be breaking new ground, with an approach unlike previous national inquiries, but it is still expected to begin its real work this spring. Up to now, the work (and a good chunk, 10 percent, of the commission's \$53.8 million budget) has been largely focussed on setting up the protocols and infrastructure for the inquiry. The inquiry mandate is set over two years. At the inquiry update Justice Buller noted the commission will focus its funding evidence-gathering, on research and consulting with survivors and families.

Unlike most previous national inquiries, the national inquiry into missing and murdered indigenous women and girls will "entitled to receive be information which might not otherwise be admissible in evidence in a court,' noted inquiry lead counsel Susan Vella. The commission of inquiry will only enter communities where they have been invited, and protocols will vary depending on the First Nations territory in which they are operating. The need for maximum flexibility means this commission will be breaking a lot of new ground as it does its job. Adding another layer of complexity will be the inclusion of lesbian, twospirit and transgender people, requiring a wide set of options when it comes to collecting its data

"Information may be received by the commissioners through various different mediums ranging from people telling their stories to the commissioners directly, to people providing the information by way of a written statement, to trained statement takers, or through forms such as poetry, art, and audiovisual statement," Ms. Vella said, adding that the normal rules governing evidence will not apply. The hearing rooms are not likely to be set up anything like formal courtrooms, according to the lead counsel. There will be no crossexaminations.

But there will be ceremonies and storytelling included in the process, and families who wish to testify together as a group will be allowed that ability.

A major difference in this inquiry is that each province and territory will be able to compel evidence from institutions and government agencies within their jurisdictions, greatly MMIWG commissioners had a press conference yesterday, (where) they made a decision not to include the missing or murdered aboriginal males after all," noted activist John Fox in the immediate aftermath of the announcement. "What a big let down." But after digesting the

news, Mr. Fox managed to find a mote of light. "More men and boys can present at inquiry," he noted, "but it's minimal involvement. No problem. At least they'll have a forum to talk."

Anishinabek Nation Council Chief Grand Patrick Madahbee said that he too was disappointed that the commission will not be expanding to include men and boys. "It has taken a long time to roll out," he said. "The Chiefs of Ontario are still organizing an Ontario approach. There is a meeting taking place on the issue soon.

Chief Madahbee said

expanding the available data to inform the commission's eventual findings and recommendations.

There will, however, be no forensic review of cases involving men and boys, noted Ms. Vella, although the commission will take into account "relevant" testimony from indigenous men and boys. that it has always been the position of the Anishinabek Nation that the inquiry should be expanded. "There are a lot more murdered and missing men," he noted. "It has been a push of the Anishinabek Nation that they should be included."

SUDBURY—Ronald McDonald House Charities (RMHC) Toronto is expanding the support it provides to families of seriously ill children in Northeastern Ontario.

On Monday, RMHC Toronto officially opened its Family Room at Health Sciences North (HSN), providing a "home away from home" for families just steps away from the NEO Kids paediatrics and neonatal intensive care units where their child is being treated.

The Family Room provides a welcoming and comforting environment where parents can rest and recharge away from the clinical environment of their child's room. Research shows that parents who stay close to their ill children are able to be more involved in clinical decision making and care and have more positive hospital experiences.

RMHC Toronto supported 164 families from Northeastern Ontario at its House last year when their child required lifesaving treatment in Toronto. With the opening of the Family Room at HSN, RMHC Toronto can now support hundreds of additional families from Northeastern Ontario-while their child is hospitalized in Sudbury. HSN supported 1,200 patients and families last year in its NICU and paediatrics unit.

The Family Room includes a kitchenette stocked with snacks and beverages, a relaxing fireplace lounge with TVs, and two rest and respite areas, with a total of six recliners, where families can nap and sleep. Inspired by first-class airline lounges, the recliners have custom-built privacy screens to allow family members to rest without distraction.

The Family Room is staffed from 9 am to 9 pm, seven days a week, by RMHC Toronto volunteers, all from the Sudbury area. The recliners are available to families 24 hours a day.

'The Family Room at Health Sciences

North is a core part of our mission to provide an environment that keeps families close so they can cope during a stressful and frightening time," says Sally Ginter, chief executive officer, RMHC Toronto. "We are grateful for our partnership with this hospital, and grateful for the many people, including our volunteers and donors, who are enabling us to support more families than ever before in Northeastern Ontario.

'This partnership with Ronald McDonald House Charities Toronto is improving care for our patients and families from across the North East," says Dr. Denis Roy, president and CEO of Health Sciences North. "It is comforting to know that in their hour of need, families will be better supported while their children are receiving care at HSN. Families will have an area to rest and regenerate and remain close to their loved ones. Thanks to the team at Ronald McDonald House Charities Toronto, and to the many donors and volunteers for providing this quiet retreat for our families.'

Since the Family Rooms at HSN first opened on December 1, 2016, there already have been close to 1,600 visits by 88 different families.

'The Family Room is just what I needed," says Susan St. Georges, one of the first people to use the room after her son Benjamin was born prematurely in December and spent time in the NICU. "I could relax and destress without leaving my son's side.'

The Family Room at HSN is the seventh in-hospital Family Room opened and operated by RMHC Toronto, but it is the first one out of the Greater Toronto Area. RMHC Toronto also operates Family Rooms at Rouge Valley Centenary, The Hospital for Sick Children, Markham Stouffville Hospital and Credit Valley Hospital.

3) You must understand whom Jesus is and that he died for your sin.

You must understand your own sinfulness.

5) You must confess this sin. (That you have walked contrary to God's instructions.)
