Murder charge laid in Wikwemikong 45-year-old Frank Osawamick found dead Sunday

WIKWEMIKONG—Tragedy has struck the community of Wikwemikong with news of the untimely death of 45-year-old Frank Osawamick, a husband and father, allegedly at the hands of 48-year-old Julius Trudeau who has been charged with second degree murder.

On Sunday afternoon, February 28, Wikwemikong Tribal Police were alerted to the body of Mr. Osawamick at a Wikwemikong Way apartment complex located adjacent to the Wikwemikong Nursing Home. As of press time Monday, it was not known to whom the apartment where Mr. Osawamick's body was found belongs. Unconfirmed reports state that Mr. Osawamick

had been stabbed. Mr. Osawamick and Mr. Trudeau were acquaintances,

police confirmed.

The Ontario Provincial Police (OPP) North East Region Crime Unit and OPP Forensic Identification Services Unit (FISU), under the direction of the OPP Criminal Investigation Branch (CIB) Acting Detective Inspector Mark Zulinski were asked to assist the Tribal Police.

As a result of the investigation, Mr. Trudeau, age 48 of Wikwemikong, has been charged with Second Degree Murder contrary to the Criminal Code of Canada.

Mr. Trudeau appeared in bail court on Monday and has been ordered held in custody until his next court appearance at the Ontario Court of Justice in Gore Bay on March 10.

Ontario budget assists low income seniors, students while higher earners will pay more

Everyone taxed on carbon consumption to lower greenhouse gas

TORONTO—Ontario's 2016 budget has hit the newsstands in a flurry of spin and counter spin, with the most common headline featuring news that some students in Ontario will be receiving what amounts to free post-secondary tuition—but the bottom line of this budget remains written in red, albeit in a lighter shade.

The 346-page budget contains nearly \$134 billion in spending, but lays out the government's planned route to an elimination of the \$5.7 billion provincial deficit by the end of March 2018.

The deficit for the 2015 year ending March 31 fell to \$5.7 billion (from an previously anticipated more than \$8 billion) and by 2017 the deficit is expected to drop to

\$4.3 billion, reaching balance in 2018. But deficit reduction along that charted path calls for new revenues, cutting costs and continued economic growth. A sudden downturn could disrupt the Liberals best-laid plans. On a bright note, projections by Mike Moffat, chief economist at the Mowat Centre, heard by delegates to the annual ROMA/OGRA combined conference in Toronto last week was surprisingly upbeat—the first such positive report in several years.

Algoma-Manitoulin MPP Mike Mantha was highly critical of the budget, noting that seniors will be paying more for prescription drugs, the cost of gas and heating will rise under the cap and trade program (although the NDP have supported cap and trade, they do not approve of the Liberal imple-

Manitoulin Pet Rescue seeks foster homes for cats and dogs

MINDEMOYA—Islanders were happy to learn in 2015 that an umbrella organization, Manitoulin Pet Rescue, had started up for Manitoulin. The idea for the association came from Holly Scott of Mindemoya and she, along with Spring Bay resident Julie McDermid, spoke to The Expositor.

"We wanted to support and assist the existing local pet rescues," Ms. Scott, who manages the finances of the group, said. "And to take responsibility for our local needs, to make it easier for the people of Manitoulin to adopt a healthy, spayed or neutered pet, intervene in cases of animal abuse and to use the local resources for managing the pet rescue work.

They explained that Manitoulin Pet Rescue is a volunteer operated, not-for-profit charitable organization with the goal of rescuing and re-homing the unwanted or displaced dogs and cats of Manitoulin Island. The first dog rescue came in late September 2015 and shortly after came the first cat rescue.

The purpose of the organization is to place dogs and cats into caring and committed foster homes to assess each animal indi-

vidually for their needs in order to find them permanent, responsible 'forever homes.' The members of the group work closely with two other volunteer groups which are Fixing Our Felines and PetSave

Rainbow Board seeks community uses for surplus Manitoulin classrooms

SUDBURY—As populations shift, expand and shrink across regions, school boards are faced with some of their most difficult decisions, how to deal with schools whose regions no longer support the size of the schools they once did. Although Manitoulin Island's

many small Rainbow District School Board (RDSB) schools are somewhat insulated from the threat of closure by the distance that lies between their communities, that doesn't mean that economies might not be sought and found, some more distasteful than others.

A series of three community meetings were held recently, one in each of Sudbury, Espanola and the last in Little Current, that sought to find ways to utilize the excess space to be found within Island schools that would complement the educational nature of those institutions.

"We had a great turnout," said RDSB Director of Education Norm Blaseg. "There were representatives from a number of Island municipalities, the District Services Board and even a mayor and a CAO."

The meetings, which the RDSB hopes will be held on an annual basis going forward, sought input on the possibilities to utilize the spare capacity that lies within Island schools. The Island schools, whose communities are by and large growing older and smaller, each have more space than required for their current (and more importantly in some ways, future) enrollment.

Doggie day care owner concerned changes to animal control bylaw will shut down business

LITTLE CURRENT—A Little Current business owner is concerned about how changes to the Northeast Town animal control bylaw will affect his business.

The Northeast Town council was scheduled to reviewed recommended changes to the bylaw from the community services and public works committee at last night's (Wednesday, March 1) council meeting.

The major proposed change to the bylaw was the definition of 'kennel,' limiting kennels to an area zoned for the purpose of boarding and breeding dogs and associated commercial activity and only on prop-

erty of at least five acres.

Under the changes, kennels would be defined as "a building, structure or fenced area (or part of) where dogs are kept, raised, boarded and used for commercial purposes including, but not limited to, the keeping of rescue animals and operating doggie day-cares."

"The changes to this bylaw will shut down my business," said Scott Richer, owner of Ruffin It Pet Services. "We have had no complaints to us, no issues, never a dog bite, or a noise complaint—our neigh-

Espanola OPP could become part of the Manitoulin fold

MANITOULIN—The idea of the Manitoulin detachment of the Ontario Provincial Police (OPP) adding the Espanola OPP station to its fold (currently Little Current, Manitowaning, Mindemoya and Gore Bay) is currently in the consultative phase with Manitoulin OPP Detachment Commander Staff Sergeant Kevin Webb attending a meeting of the Manitoulin Municipal Association this week to discuss realigning detachment boundaries.

Staff Sgt. Webb told The Expositor that making Espanola a satellite detachment office of Manitoulin is just in the consultative phase among local mayors, reeves, councillors and officers, but if it were to go ahead, it would mean no changes to Island operations with the exception of adding resources.

It all comes down to fiscal

responsibility, Staff Sgt. Webb explained. "This has been in the air for awhile. Espanola is a natural fit for us." Currently, the Espanola detachment falls under the Sudbury detachment.

"Nothing would happen soon—it's a process," he added, noting that it will also require the blessing of the province. "But nothing changes here. Head office will remain in Little Current."

When asked if this had any bearing on talks in recent years of possible Island detachment closures, the staff sergeant said it did not, nor are those talks on the table anymore. "Long term, we will need to upgrade the facilities and, if at that time we need to build new detachments, there could be discussion as to where to build," he said, but reiterated that this would be long term.

Debaj hosts major Canadian theatre production 'Huff'

MANITOWANING—Debajehmujig is continuing its long-standing tradition of bringing international calibre theatre to Manitoulin Island by hosting the major Native Earth theatrical production 'Huff' at its Manitowaning Creation Centre.

Huff is described as a "daring solo show by award-winning indigenous play wright Cliff Cardinal, one of the most exciting new voices in Canadian theatre." Huff is currently on a cross-Canada tour and Debaj is presenting it in partnership with Native Earth Performing Arts of Toronto. The tour had stops in Calgary, Edmonton, Vancouver, North York, Quebec City, Montreal, Kelowna, Victoria and, yes, Manitowaning.

"The show explores some pretty hard hitting issues, including substance abuse," said Debajehmujig Storytellers Artistic Director Joe Osawabine. Huff is the "wrenching, yet darkly comic tale of Wind and his brothers, caught in a torrent of solvent abuse and struggling to cope with the death of their mother."

In the 70-minute production, the story is brought to life as "Wind's fantastic dream world bleeds into his haunting reality, as he's preyed on by the Trickster through the hallways at school, the abandoned motel he loves more than home, and his own fragile psyche."

"We are really excited to be able to bring this production to Manitoulin Island," said Mr. Osawabine, who noted that art can bring remarkable clarity and insight to the issues that are reverberating through First Nations, helping to create some of the building blocks of a real reconciliation between Canada and her first peoples. "Being the only aboriginal arts organization who owns and operates their own facility we feel a responsibility to present the work emerging from the indigenous body of work in Canada today," he added.

Huff is directed by Karin Randoja and stars Cliff Cardinal. He noted that Cliff Cardinal is the son of famed Canadian actress and member of the Order of Canada Tantoo Cardinal.

"We aren't currently funded to present this work in any way yet," said Mr. Osawabine, "but we feel it is important to get this work to our local audiences."

There will be two performances of Huff, the first on March 3 at 1:30 pm and the second on March 4 at 7:30 pm. Both performances will take place at the Larry E. Lewis Studio at the Debajehmujig Creation Centre in Manitowaning and are \$20 for general admission.

Upcoming dates for high profile Manitoulin Island court cases

MANITOULIN—This spring will see continuing court dates in Gore Bay for some of Manitoulin's recent high profile ongoing criminal cases.

Kimel Corbiere, charged with the first degree murder of M'Chigeeng elder Johnny Panamick, will be before the courts for a discovery hearing slated for March 18. Mr. Kimel was recently involved in a weeks-long preliminary hearing, which wrapped up late last month.

Robert Travis Wemigwans, Tammy Trudeau, both of Wikwemikong, and Byron Kagige of Hamilton will again be in Gore Bay court on March 21 on their charges of second degree murder in the death of Percy Simon on May 17, 2015 to set a date for a judicial pre-trial for a focus hearing and preliminary hearing.

Lastly, accused Little Current arsonist Clinton Haggart will be before the court of April 5 for a judicial pre-trial in Superior Court.

Best Picture Oscar highlights importance of newspaper journalism

'Spotlight' documents true account of reporters uncovering social evils

Two weeks ago in this space, the editorial commentary focused on how newspapers, in particular community newspapers that are locally owned and operated, if they continue to do a good job of reflecting their communities in their news pages will continue to have readership and the accompanying advertising support.

The commentary gave, by way of an example, a southern Ontario paper that, when it became part of a large chain and was no longer under local ownership and management, lost its way and its readers too. When it came back under local ownership and management and once again focused on its community, its readers returned, bringing with them business support.

This commentary was written by way of a local response to the predictions of the demise of the newspaper industry and of professional news gathering by pundit after pundit over the past six months.

Sunday's Oscar awards, that gave the Best Picture award to a reenactment of an important and true news story that played out in the newsroom and in the pages of the Boston Globe, serves to underscore the importance of professional, dedicated reporters whose work is subjected to editorial checking for factual accuracy before the paper commits the story to print.

In its way, the Boston Globe is a community newspaper similar to this one or the Sudbury Star or the southern Ontario paper used as the earlier example.

The Boston Globe has a larger circulation, certainly, and it publishes seven days a week.

But its focus is on the city of Boston, unlike the Globe and Mail in this country or the New York Times in the United States that are national publications.

The Oscar winning movie is called 'Spotlight' and is based on the experiences of the Boston Globe's editorial staff in uncovering the abuse of hundreds of children by Roman Catholic clergy in the Boston area over many years.

The paper's reporters dug deep and found out that the church's hierarchy was aware of many of the abusive priests and, rather than removing them from pastoral work where they would have access to children, these pedophiles were routinely simply moved to other parishes.

The picture won the most coveted Best Picture Oscar this year because it told an important story, one that will doubtless bring a

great deal of pressure on the Roman Catholic Church in particular, but also on any other similar institutions as well, to develop proper policies of dealing with pedophiles they might find in their midst.

But, significantly, the movie was in this case only the retelling, in a more dramatic medium, of a true story that came to light thanks to the diligent efforts of investigative reporters at the Boston Globe.

In effect, the Best Picture Oscar this year has gone to a hybrid drama-documentary about the workings of a newspaper doing the kind of work it, among all other forms of media, is best equipped to do.

The current conversation about the state and future of journalism will go on but the unique prominence this movie award will give to the practice of quality and socially urgent reporting should give the "newspapers are dying" and "reporting can be accomplished by bloggers" points-of-view an excellent reason for the people who hold these positions to reconsider their opinions.

As long as they have the resources, no news institutions are better equipped to accomplish this kind of investigative journalism, the kind that nearly always leads to social change, than are newspapers.

A great deal of the "news" broadcast via social media is opinion or anecdote or information received third or fourth hand and then passed on and on.

Yes, the reach of social media is impressive, but with the exceptions that are countable on one hand, there is no investment in the editing process that vets the first draft of a story, and often the second, and sends it back to the reporter with suggestions for more digging.

That's what newspapers, large and small, do and the Best Picture Oscar about the process at the Boston Globe, as the paper went about covering a story with international implications, shows this off to perfection.

For its work on this important story, the Boston Globe was awarded a Pulitzer Prize, US journalism's highest honour. For the record, 30 years ago The Manitoulin Expositor became the first weekly community newspaper to win the Canadian equivalent prize, the Michener Award for investigative work that led to significant community changes and so helped address a serious Manitoulin Island social issue. Since that time, there has been only one other weekly newspaper chosen to win this annual National award.

By all means, see 'Spotlight.' By all means, think about the importance of sustaining this important news gathering medium.

By having more resources provided by the government will make access to health care easier. Funding health care research and clinical trials will increase our knowledge on diseases and aid us in treating the diseases. In the end, it all comes down to money and how much of our tax dollars are going towards the health care sector and also how much the government is looking into funding the health care system.

One year marks the anniversary of "Je suis Charlie"

Just because we can say something, does that mean we should?

To the Expositor:

Je suis Charlie. It was the statement du jour on social media as a response to a literal attack on freedom of speech following the shooting at Charlie Hebdo, a French satirical weekly magazine. An attack we all understood was meant to deny freedom of speech. On January 7, 2015 two men claiming to be Islamist terrorists killed 11 and injured 11 more at the magazine's head office in Paris. While we marked the 1 year anniversary of the attack, Charlie Hebdo is in the news again after printing a cartoon that depicts a boy lying face down on a beach while men chase women around with the caption suggesting that drowned refugee Alan Kurdi, should he have grown up, could have become a predator, after refugees raged against women on New Year's Eve in Cologne, Germany. "Migrants: What would little Aylan have become if he had grown up? A bum groper in Germany."

Book encapsulates a family's history building securing memories for future generations

MINDEMOYA—Ann Zylstra-Marissen sits at the table in the dining room of her immaculate apartment in the Sparrow's Nest seniors building in Mindemoya and describes her long journey in creating her book 'May the Favour of the Lord Rest Upon All Generations.'

The 100-page volume documents the histories of the various branches of her family in what is truly a labour of love. "Ever since our families immigrated to Canada there was talk about the origins of our ancestors," she said. But like many Canadian families, most family members' memories did not stretch beyond the sketchiest of details of the lives of their great grandparents. "We would ask each other where our grandparents came from," she recalled. A few clues were available, such as her Grandmother Marrissen's Low German words "so we knew she must have lived in Germany," she said. "Grandfather Marrissen we knew nothing about. The same thing happened to all the other grandparents and ancestors."

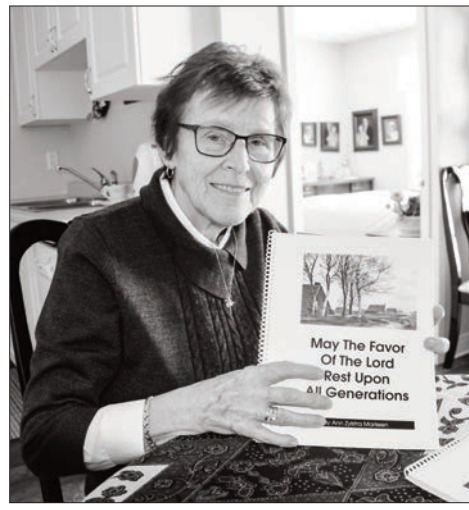
As all of the older relatives had passed beyond the reach of any inquiries, she began to explore the collection of old books her father had stored in his garage. Although those books did not directly relate to her family, the details contained within those tomes describing where her family originated helped put each member in context of their times and lives.

"I also wanted to write about church and civil politics," she said. Ms. Zylstra-Marissen bristled at the commonly held notion that the family's ancestors had been illiterate. "How could they run a business where so much reading, writing and arithmetic would have been involved?" she asked.

Ms. Zylstra-Marissen admits that some of the "history" that she relates in her book as to the families' lives is fictionalized. "For some of the families I had to fabricate stories," she said, "but everything sounded very logical and believable." As such, this is not a "history book, but a book of stories with I hope much history."

A photograph on the front cover of the book shows the kind of homes that the farming families would have lived in during the 1700s. "Be sure to tell people that," she laughs, "I wouldn't want people thinking that is how they live now."

Although the road leading to the homes is dirt, the homes themselves look quite cozy and robust, if rustic. The buildings are very apropos, as the earliest family entry dates to 1685 and peat bogs figure very prominently in the stories. Some ancestors made their living from the harvesting and sale of peat and turf, while others hewed fertile lands through the building of canals, ditches and dikes, digging the base sand and clay from beneath the peat bogs to create a wonderful soil. Think the Holland Marsh just north of Toronto, where early Dutch immigrants did the

same in this country, and you will quickly get the idea.

Much of the research conducted by Ms. Zylstra-Marissen in the writing of her book was of necessity done in Dutch, for the families largely hailed from the Low Country region of Europe encompassed by

the modern-day Netherlands—still Holland to many.

The book stretches back eight generations in places and is liberally sprinkled with photographs of farms, churches and relatives and official documents.

Ms. Zylstra-Marissen credits family tree created as a school project by her granddaughter Sarah Scott Quackenbush as one of the impetus of creating the book and cites the post genealogy of the Hospers-Brandorf family as being of great assistance.

In 1949, when Ms. Zylstra-Marissen arrived in Canada as a small child with her family in the aftermath of World War II, they were fleeing a Holland still reeling from the horrors of that war. "Everything was still being rationed," she recalled. Although the family has never pined for their homeland and are proud Canadians, having become citizens in 1955 after the five-year waiting period, they have retained many of their customs and culture even onto this day.

"Would we have been able to help our kids along if our parents had not taken us to Canada?" she wonders at her book's conclusion. "Dutch culture stayed with us and some even transferred to our grandchildren, and we still speak Dutch as well as the local dialects we grew up with. We are also proud and thankful for the opportunities Canada offered us and our family."

Beyond the basin: Great Lakes water diversion in a changing world

"One small city's request for water does not seem significant—but is it?"

To the Expositor:

The city of Waukesha, Wisconsin is thirsty for Great Lakes water. The city's 70,000 residents can no longer drink from their depleted aquifer. What little water remains is contaminated with naturally occurring cancer-causing radium. Though Waukesha is on the Mississippi side of the sub-continental divide, it is mere kilometres from the Great Lakes watershed. Waukesha engineers can almost taste Lake Michigan's water—they just need a pipeline or two. Certainly, one small city's request for water beyond the Great Lakes watershed does not seem significant, but is it? What does this mean for the Great Lakes basin? What does this mean for Canada? And perhaps more poignantly, what does this potential test case mean for other thirsty cities in the context of a changing climate?

More than 35 million people, including nine million Canadians, rely on the Great Lakes for their drinking water (National Oceanic and Atmospheric Administration, n.d.). Another 70,000 people drinking from a straw (or rather, a pipeline) seems somewhat inconsequential. The concern, therefore, is not necessarily about Waukesha; the concern is about who might be next. Las Vegas? San Francisco? Nearly all states west of the Rockies have recently experienced "abnormally dry" to "exceptional drought" conditions (United States Department of Agriculture, 2015). It seems Waukesha is poised to become a precedent-setting test case for moving water beyond a basin.

Canadians are generally opposed to watershed vaulting. Great Lakes diversions are not, after all, new notions. The Chicago diversion is a century-old proverbial thorn in Canada's side. Chicago draws nearly two billion gallons of

water each day from the Great Lakes, an amount that could increase in coming years. As such, apprehension is not unsubstantiated. Even Canada's ambassador to the United States predicts water supply will become a major issue between the two countries within the next five to 10 years. Canada must prepare for water diplomacy as the US continues to run dry.

While our southern neighbours struggle to adapt to changing water patterns, it is tempting to exult in our geographical lottery. Canada is, after all, a nation rich in freshwater supply. The Great Lakes alone constitute over 20 percent of the world's freshwater supply. This oft-repeated axiom, however, is somewhat misleading. This supply cannot be utilized without completely destroying the stock. A mere one percent of the waters of the Great Lakes are renewed each year in rain and snow-melt (Environment Canada, 2013). Our water system is not sustainable. Our water abundance is a myth.

Freshwater scarcity is a global problem just beginning to touch North America. Climate change impacts on freshwater supply and quality will undoubtedly intensify in coming years. Changes in precipitation patterns, increases in temperature, evaporation, and sea level rise will continue to threaten lakes, rivers, and coastal areas. While climate scientists are quick to point out that no single event (for example, the California drought) is attributable to climate change, extreme weather events are increasingly the norm and society will be forced to adapt to these altered patterns.

The Waukesha situation is already challenging The Great Lakes Compact—a legally binding agreement signed

into law by President Bush. The agreement is an act of Congress ensuring that all the eight states touching the Great Lakes shoreline can veto water requests. Because states and provinces cannot sign international agreements, Ontario and Quebec are opinionated onlookers in these state discussions. If, however, Ontario and Quebec object to the Waukesha application, they have authority to fall back upon the Boundary Waters Treaty of 1909 (along with the bi-national International Joint Commission stemming from it).

While the Great Lakes are certainly depended upon as a water supply, they are also fundamentally important to Canada-US trade, agriculture, industry, power generation and recreation. Their vitality and abundance contributes hundreds of millions of dollars into the economy each year (Environment Canada, 2013). The stakes for water quality and supply are high. Assuming approval, Waukesha will draw 10.1 million gallons of lake water each day by mid-century (Wisconsin Department of Natural Resources, 2015). Waukesha is just one thirsty city beyond the Great Lakes basin, but it begs the question: who will be next in this era of changing climate patterns?

Minister of Tourism responds to Bill 100 concerns

An option for willing landowners to voluntarily enter agreement—no property owner would be compelled

To the Expositor:

I am pleased to have this opportunity to inform you about Bill 100, the Supporting Ontario's Trails Act, 2015 which is currently being debated in the Ontario Legislature.

We introduced the Supporting Ontario's Trails Act to improve access to Ontario's trails, building both a healthier and more prosperous Ontario. If passed, Bill 100 would help the trails community to cultivate, operate and promote trails while enhancing the trail experience for all users.

To develop the Supporting Ontario's Trails Act, our ministry held consultations with over 250 organizations, including municipalities, Aboriginal groups, trail organizations and not-for-profit organizations. The feedback my

ministry heard during these consultations was integral to shaping the proposed legislation.

We know that trails encourage people of all ages and abilities to visit our unique communities and support local economies. Each year, millions of Ontarians and visitors from outside the province experience Ontario's trails. Hiking use alone in 2014 was the source of close to \$1.4 billion of economic benefit to our province and created more than 18,000 jobs across the overall Ontario economy.

This legislation would connect and expand trails across the province, increasing the economic benefits for local communities. It would promote tourism and encourage use of the trails system by enabling the recognition of trails of distinction and proclaiming an annual Trails Week to coincide with International Trails Day in June.

This legislation would provide an option for willing landowners to consider entering into an agreement to allow some or all of their land to be utilized for trail related activities. To be clear, an easement pursuant to Bill 100, if passed, would be a voluntary agreement between a landowner and an eligible body or bodies. No property owner would be compelled to provide an easement unless they agreed to do so.

The Supporting Ontario's Trails Act would help us to protect and improve thousands of kilometres of the province's trails network while encouraging its expansion. I look forward to continuing debate on this important piece of legislation.

Manitou subdivision

Council carried a motion that they had no comments or concerns with the application.

Council supports Autism Awareness Day

The Northeast Town council reviewed a letter from Autism Ontario, requesting council proclaim April 2, 2016 World Autism Awareness Day and raise the Autism Ontario flag on Monday, April 4. Council carried a motion granting the request.

Victim Services donation

A motion moved by Councillor Erskine and seconded by Councillor Melissa Peters to donate \$200 towards the Manitoulin Northshore Victim Services curling funspiel was defeated. A funding request from the organization stated that the funds raised from the event will go towards providing enhanced services to community members who are victims of crime and tragic circumstances and to make emergency hygiene kits and towards emergency home safety devices.

Military Service Recognition Book

Council reviewed a request from the Royal Canadian Legion to purchase an advertisement in the Military Services Recognition Book.

"A minimum 20,000 copies will be available free of charge at the local Legion branches and most importantly the book will be provided to schools and public libraries to help the younger generation better understand the sacrifices made by our veterans," stated a letter from the Royal Canadian Legion to council.

Town CAO Dave Williamson explained that in the past the advertisement was purchased out of staff's advertising budget and asked if council would like to direct staff to do the same this year. Council indicated that they did. Councillor Marcel Gauthier commented that it was "money well spent."

Police continue to conduct cottage property checks

The Manitoulin Detachment of the Ontario Provincial Police (OPP) continues to conduct property checks of seasonal residences by snowmobile and patrol vehicle in an effort to prevent property crime.

Property owners can do their part by making their cottages as theft resistant as possible. Remove valuable items, or lock them out of sight. These items may include electronics, and tools. Remove alcohol from seasonal residences. Do not leave boats, all-terrain vehicles (ATV) or other vehicles out in the open and unsecured. Lock them up in a garage and remove the key. If you must leave them outside, lock them to a tree or some other permanent structure. Drain the fuel tanks and take used fuel away. Do not leave gas cans as it may be used to steal your boat, or ATV. It also reduces the risk of a fire on your property. Use quality locks including dead bolts on doors and windows. A simple piece of wood will secure sliding doors and sliding windows. Cover window openings to prevent a view of the interior.

Tell neighbours that the seasonal home is vacant. Permanent residents living close by can be your eyes and ears when you are not there. If your area has Neighbourhood Watch, advise the block captain when you are leaving for the winter. For more information check the Crime Prevention Section on the OPP website at www.opp.ca.

Break and enters are crimes of opportunity. The OPP is asking the public to be vigilant and to report suspicious activity around these vacant properties. Take time to note the time of day, vehicle description including license plate, and a physical description and clothing of any individual observed. Timely reporting of this type of activity to your local OPP detachment will allow police to quickly determine if further investigation is required.

"This month at the recreation centre minor hockey play-offs begin and the Panthers season continues," said Mr. Taylor. "Manitoulin Secondary School playoffs are also happening and the winter walking program is continuing. We have a wedding fundraiser on February 27 and the

Skate Canada Ice Show on March 5. Lisa (Hallaert) is planning lots of great March Break activities for kids from March 14 to 18."

Mr. Taylor added that the recreation centre is hosting the Northern Ontario Hockey Association Tournament of Champions March 18-20.

"The building and parks are being monitored and the Sisson Park Ice Rink was re-opened on February 12 and will continue weather permitting," said Mr. Taylor. "Spider Bay Marina facilities are being monitored and we have included proposed marina rates for 2016."

Kevin Dunlop was introduced to council as the public works assistant foreman. He presented the public works report for February. He noted that regular winter maintenance was being done on the roads and that the equipment was being repaired and maintained as required. Mr. Dunlop also told council that Kevin Taylor has been hired on contract for the winter months, replacing an operator who is off.

Marina rates

Council discussed the proposed marina rates, which included a slight increase in rates. Mr. Williamson discussed how most of the rates weren't increasing by very much because the town didn't want to chase away its customer base.

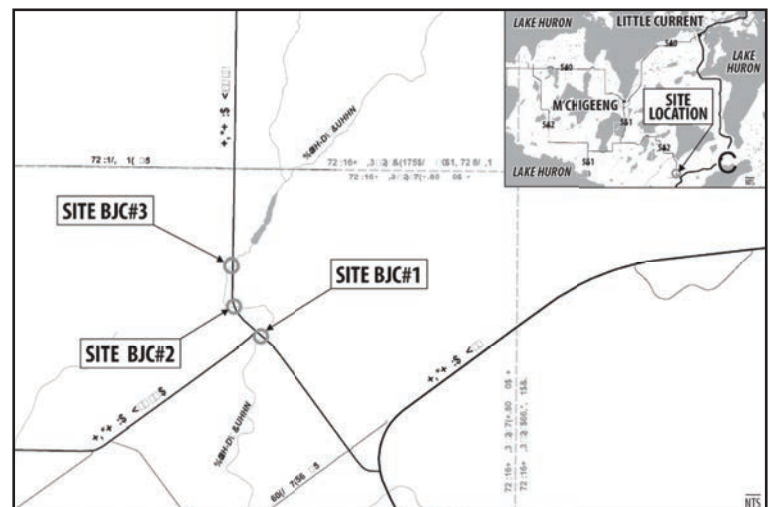

Assiginack Council Notes

Snowshoeing fun

Councillor Leslie Fields spoke of the snowshoeing trails located at McLean's Park on New England Road. She told her fellow councillors that, by the end of winter, the trail will have seen over 500 kids traverse the route. Councillor Fields also noted Steve Hart, Rob Mellan and Ron Cooper's work with the kids and encouraged her fellow councillors to go and check it out. The trail is also used as a practice trail for the Manitoulin Special Olympic snowshoe team.

"(The late) Mr. McLean would be so happy the park is being used like this," Councillor Brenda Reid added.

Accounts for payment

Council authorized the following accounts for payment: general, \$174,816.09; and payroll, \$17,607.61.

Health Board teasers

After reviewing the Sudbury and District Board of Health minutes, Councillor Fields said that it is not unusual for the municipality to first learn of changes in government funding through the minutes with very little information on the subject. Council noted that Ken Noland is the Island representative on the board and should be reporting more frequently to the Manitoulin Municipal Association.

Burns Wharf architectural services

Following a review of a letter from Castellan James and Partners Architects Inc. on services for the Burns Wharf Theatre, CAO Alton Hobbs suggested that a committee of council be established. Council decided this would be done at the next regular meeting. A motion was carried to authorize the services and approve the \$9,800 fee plus disbursement and HST for Castellan James and Partners Architects Inc.

New streetlight debate

Council received a quote from JJ Pole Line for the installation of a streetlight at Sucker Lake Road and Highway 6 in the amount of \$5,800.

"Is this kind of money warranted?" Councillor Fields asked.

Councillor Moggy suggested waiting until the budget was set.

"But is it an opportune time now?" Councillor Fields questioned, noting the LED streetlight replacement project currently underway. "But I do question the need—there's not a lot of people there."

Mr. Hobbs said the streetlight would be purely for the landfill.

Mayor Paul Moffat added that all of Assiginack's population is limited. "Let's face it."

"The cost is not huge," Councillor Reid said. "I would like to see a light there too."

Council tabled the discussion to the next meeting of council.

Municipal highway maintenance

Council was given a copy of Assiginack's 'Minimum Maintenance Standards for Municipal Highways' to review. It was explained that roads superintendent Ron Cooper wondered, as part of budget deliberations, if council wanted to review the roads and move any to a different class.

"I see this as having quite the impact for budgeting purposes," Councillor Fields said.

"I agree," said Councillor Reid. "Roads are huge budgeting issues. I don't think we should touch them without a traffic count."

"I'd like to go through it with Ron," Councillor Moggy added.

Mr. Hobbs said a traffic count should wait until May or June, which would have the effect of pushing the budget back to June or July of this year.

Both Mayor Moffat and Councillor Reid agreed that if council decided to go with a traffic count, any decisions on roads should wait until the next budget year.

Support for Sudbury, Aurora resolutions

Assiginack passed a motion supporting a City of greater Sudbury resolution to expedite the return of the OPP search and rescue helicopter to the Sudbury Airport "to better serve the needs of Northern communities" as well as the Town of Aurora's resolution regarding their request to the Government of Ontario "to limit the jurisdiction of the Ontario Municipal Board to questions of law or process and for the Ontario Municipal Board to uphold any planning decisions of municipal councils, unless they are contrary to the processes and rules set out in legislation."

Preparations underway for second Knox Charity Golf Tournament

mentation plan as it lacks protections for consumers and provides exemptions for corporate polluters).

He pointed out that the budget fails to address key shortfalls in health care and education spending, while at the same time tacking on new cuts. "Seniors will see their drug costs nearly double with this budget," agreed NDP Leader Andrea Horwath in her remarks about the budget. "Patients will continue to wait too long for surgeries. Students across the province will continue to suffer cuts to their education."

Mr. Mantha asserted that the provincial Liberals could have built on Ontario's potential with this budget, but they had clearly missed the mark.

Even as it brings the overall numbers into balance, the Liberals are slated to add \$30 billion in debt to the government's deficit tally over the next three years, and by the end of March 2019 that deficit is anticipated to top \$326 billion. A cautionary note is that the cost of servicing that debt produces the third-largest single line item in the 2016 budget, only outpaced by health care and public education. The servicing cost is estimated to be \$11.8 billion in the 2016/17 fiscal year, moving that item ahead of spending on post-secondary education or welfare.

If it isn't the sale of Hydro One, cap and trade or the continued deficit that is hitting the headlines, the top contender would likely be the promise of free tuition for students from households with an average annual income that falls below \$50,000 and that free tuition will also be available to some students in graduate programs who qualify for the Ontario Student Assistance Program. At least half of students from households earning less than \$83,000 a year will also pay no tuition through the combining of grant programs and those from higher income families will either see a reduction in fees or pay the same amount. The government is reworking existing grant programs and claims that the new program will not cost more money.

Ontario companies will soon be trading carbon credits with California and Quebec, as Ontario moves to a cap and trade program within a year. The province asserts that cap and trade will raise \$1.9 billion in its first year, and that they will funnel that largesse back into eco-friendly programs—the opposition claims it is a Liberal cash grab. The carbon-pricing effort will have some costs for consumers, including a 4.3 cent hike on the price of gas and heating costs will rise. The cost of electricity is not expected to be impacted by this program.

Higher-income seniors will see their annual deductible for the Ontario Public Drug Program increase to \$170 a year from \$100 and they will be required to co-pay a dollar more per claim, but for 170,000 low income seniors in the province, the costs will drop substantially. The province promises to overhaul the entire drug program by 2019. Seniors will also be receiving free shingles vaccine.

One other reform is anticipated to allow pharmacists to administer travel vaccines (they're already allowed to give flu shots).

The Drive Clean program will be getting an overhaul, and drivers will no longer have to pay a \$30 fee for a Drive Clean test to ensure vehicles meet emissions standards. The program will continue, despite both the environmental commissioner and the auditor general saying the program is redundant, unfortunate since it will cost the province \$60 million a year.

There will be 70 grocery stores allowed to sell wine by this fall, and eventually that number will rise to 300 grocery stores. Small increases to the minimum cost of wine,

cidiers and fortified wines will see the minimum cost of a 750-millilitre bottle increase to \$7.95. The change is expected to raise \$15 million in 2016 fiscal year, \$45 million in 2017 and \$75 million in 2018.

The budget promises cheaper parking for frequent hospital visitors: they will be able to buy cheaper, transferable passes with in-and-out privileges or save 50 percent on multiple-use passes at hospitals that charge more than \$10 a day.

On the pension front, the Ontario Retirement Pension Plan will continue to move toward the delayed 2018 rollout, with an escape clause should the federal plan step up enough.

There are plans in the budget to reduce Workplace Safety and Insurance Board (WSIB) payroll premiums by about 40 percent over the next two decades, that is if the fund reaches full funding by 2022.

The province will raise welfare rates slightly, by an increment of 1.5 percent to Ontario Works and Ontario Disability Support Plan rates and increasing the monthly amount for single adults on either of those plans by \$25 a month.

The budget promises 80,000 more home-care hours from nurses for the province's sickest patients to help people age at home or die in their own residence.

As part of a broader strategy to tackle violence against women, the budget also promises \$2.4 million a year to help survivors of domestic abuse find new homes.

The province has announced in the budget it will run a pilot program in one community to try out a guaranteed annual income plan that will replace welfare.

The province has pledged \$1 million to increase supports for families experiencing the loss of a baby during pregnancy and the province plans to build three rooms to allow for the transplant of stem cells as cancer treatments, one in Toronto, one in Hamilton and one in Ottawa.

The vaccine debate has hit the budget table, with plans to tighten the rules for vaccines in schools that will mean it will be harder for parents to send unvaccinated children to school.

Sin taxes are rising, with tobacco taxes jumping \$3 per carton, a move to increase smoking cessation that will cause an average pack of 20 cigarettes to go up by at least 30 cents and a large pack of 25 to rise by 38 cents.

Two tax credits will be disappearing. The Healthy Home Renovations Tax Credit, intended to help seniors modify their homes to make it easier to age in place, is being cut due to low subscription (those that did buy in were predominantly the more wealthy) and will save \$15 million a year. The Children's Activity Tax Credit, which also seemed to only benefit wealthier families, is also going the way of the dodo, saving \$55 million a year.

We will have to wait and see what new or increased service fees will appear to increase revenues, including those for drivers' licences, as the budget says they are coming, but not by how much. The province's modernize of ServiceOntario will allow more online services, such as changing one's address on their drivers' license and health card—likely leading to fewer humans helping humans in centres across the province.

There will also be \$5 million over three years to increase education about the treatment of indigenous children in residential schools as was recommended in the Truth and Reconciliation report.

The budget promises \$2 million to help the more than 10,000 Syrian refugees that will settle in Ontario to integrate into Canadian society.

Manitoulin. As Ms. McDermid explained, the new organization shares resources, fosters and experience and knowledge with the existing groups.

Manitoulin Pet Rescue is sustained by public donations and adoption and surrender fees. All money goes directly into the care of the animals in the program whose members are waiting for a registered charity number as they have received notice from Canada Revenue Agency (CRA) that it is pending. Once the number is received, the organization will be able to issue tax receipts for all donations. All

monies donated can be brought to Scott's Veterinary Services or The Island Animal Hospital, as well as Kat's Pet Supply in Mindemoya.

All the animals coming into the program are fully vaccinated, spayed or neutered, wormed, defleaed and receive a complete health check. It can cost up to \$500 for each dog before they are ready for adoption and the cost for cats can range from \$200 to \$250 so donations are badly needed and much appreciated.

The adoption fees are \$300 for each dog and \$180 for each cat, although special rates may be given for different circumstances.

Manitoulin Pet Rescue is looking for help with the care of animals. This includes fundraising volunteers, drivers to transport dogs or cats to medical appointments or to their foster home and fosters.

There are a few people already fostering for the organization including Matt Elgie and Donna Boyer Briglio, both of Gore Bay.

"Matt was our first foster," Ms. McDermid said. "He fos-

With shrinking enrollment numbers, there are really only three sources of economies (aside from closure) available to school boards faced with basically fixed costs for heat and hydro and maintenance.

One of those choices, allowed under the provincial provisions that govern school boards, is called "right sizing." Under that option, portions of a school are bulldozed to bring its size closer to that dictated by the funding available for the size of its enrollment. "That is something we really do not want to do," said Mr. Blaseg, who pointed out that demolition of a perfectly functioning portion of a building is a tremendous waste. But right-sizing does reduce the ongoing costs of maintaining services to a building.

Another even less palatable choice is the reduction of services to the students, lowering the number of teachers, educational assistants or specialized educational services provided at the school to meet the cost of funding. "That is something we really do not want to see happening in our schools," admitted Mr. Blaseg.

The third option, and potentially the easiest to swallow, is finding convergence of interest with other community service providers to utilize the excess space, doctors, dentists and social services coming in high on the top of the list.

"This can work out well for both the students and their parents," noted Mr. Blaseg. "Parents are already used to coming to the school and the students would not have far to go to access such services."

The prevalence of municipal representatives at the meetings does not come as a surprise, he noted, as the presence of a school in a community plays such a central role in attracting and keeping residents in the municipality.

As reported in the Manitoulin West Recorder, for Assiginack Public School the 2015-2016 estimated average daily enrolment is 124 and by 2019-20 it is projected to fall to 112,

tered Maska, the first dog that came into our program. Matt is wonderful with dogs and has a very calming energy." In speaking of the rescue of cats, Ms. McDermid explained that Ms. Boyer Briglio, "Rescues feral/stray cats all the time and has a huge heart for all animals. She recently just came on board to foster for us and live trapped an entire litter of kittens and their mother and we have since adopted

with on the ground capacity of 118 by 2015-2016. The utilization rate for the school for this year is 105 percent and is projected by 2019-2020 to be 95 percent. There are no excess pupil spaces currently, but there are expected to be six by 2019-2020. Using the same years for Central Manitoulin Public School the current average daily enrolment is 179, 165 projected in 2019-2020 and an on-ground capacity of 286. The school has a utilization rate of 63 percent in 2015-2016 and 58 percent utilization expected in 2019-2020; there are 107 excess pupil spaces in 2015-2016 and projected to be 121 in 2019-2020.

For Charles C. McLean Public School (Gore Bay) there is an average daily enrolment of 158, which is expected to be 139 in 2019-2020 and an on-ground capacity of 303. The current space utilization rate is 52 percent and projected to be 46 percent in 2019-2020. With 145 excess pupil spaces in 2015-2016 and 164 anticipated in 2019-2020.

For Little Current Public School, the current average daily enrolment is 323 estimated to be 318 in 2019-20 and an on-ground capacity of 518; 62 percent space utilization this year and 61 percent in 2019-2020, with 195 excess pupil spaces in 2015-2016 and 200 in 2019-2020.

For Manitoulin Secondary School the average daily enrolment is 440, estimated to be 401 in 2019-2020, with a current on-ground capacity of 744; with a current space utilization rate of 59 percent this year and 54 percent in 2019-2020 and 304 excess pupil spaces in 2015-2016 and 343 excess pupil spaces in 2019-2020.

The Manitoulin Sudbury District Services Board (DSB) already has a working relationship with the RDSB, as the Best Start Hubs and daycares currently operate from RDSB schools such as Little Current Public School.

Although no immediate action on joint utilization of space in Island schools has yet come about from the meetings, Mr. Blaseg said that the potential and ideas that came out of these first sessions appear to hold great promise.

Ms. McDermid, is the first step in getting the program off the ground.

Kids need consistency when it comes to reading, she explained. Ms. McDermid does not correct the children if they make a mistake (while reading) as she feels they are corrected in school and this program is meant to be fun and to encourage positive interactions between the children and the dogs.

Six-year-old Leith was next to pick a book and get comfy in the book nook and read to River. He chose 'Math Curse,' which they both enjoyed. While Leith read, it held River's attention, a gentle sweet dog.

bours love seeing the dogs playing in the outdoor fenced area. Now the town is shutting us down. We feel targeted."

"We are a small business providing a needed service to the area," added Mr. Richer. "The changes (to the bylaw) will also affect charities and animal foster families that aren't hurting anyone."

Mr. Richer said that the proposed bylaw changes, combined with other issues with the municipality and the loss of his job, have led he and his wife to consider closing their business and leaving the community.

The Expositor spoke with Northeast Town CAO Dave Williamson who assured The Expositor that neither Mr. Richer nor his business were being targeted by the municipality.

"The changes to the bylaw have nothing to do with a specific individual or business," said Mr. Williamson, explaining that council discussed changes to the bylaw to make it more detailed and clean up any confusion with specific wording and other small issues.

He also noted that the changes wouldn't affect anyone with a home business. He explained that the changes to the bylaw, if passed, would have no impact on home industry or home occupation, unless it was a commercial operation meaning that the business had employees.

However, businesses such as Mr. Richer's would be subject to the additional proposed changes to the bylaw, one of which involves barking.

"No person shall allow a dog to unreasonably disturb the peace, quiet, comfort or repose of any person or neighbour in any dwelling unit for a period of 30 minutes by way of

barking, crying or howling. Failure to do so constitutes a breach of the bylaw," states the Northeast Town animal control bylaw (the proposed amended draft).

If the changes and the additions to the bylaw are passed at the March 1 Northeast Town council meeting, anyone who is having issues with a neighbour's barking dog can contact the Rainbow District Animal Control (the town's animal bylaw enforcement agency) and request a noise log. The individual will fill out their information, the date, time and duration of the noise, and submit it to the Rainbow District Animal Control which will follow up the claim with an investigation.

See next week's Expositor for council's decision on the proposed amendments to the animal control bylaw.

Students learn about snowmobile safety and enjoy Island ride

 MANITOULIN—Several Manitoulin Secondary School (MSS) students who signed up for a snowmobile safety program learned valuable winter survival skills, first aid and snowmobiling tips and tricks during a day-long series of workshops held recently at the school with a Friday ride to the east end of the Island.

The program started on a Thursday with participants learning about the rules and regulations with Manitoulin Detachment OPP Community Services Officer Constable Steve Hart and UCCM Police Constable Murray Still.

Next was a workshop with Constable Hart and Serena Verboom of the Manitoulin Injury Prevention Coalition on the dangers of drinking and driving.

Ms. Verboom asked a student volunteer to pour a shot, a glass of beer and a glass of wine using coloured water into the designated class. The exercise showed students that 'one drink' can actually be more than you think because of the size of cup or the amount of alcohol in a beverage.

Constable Hart and Ms. Verboom used a digital board to demonstrate how long it can take for alcohol to leave an individual's blood after they stop drinking. Using the special board, the students were able to shout out if the individual was male or female, how much they weighed, what they were drinking, how often, when they started and what time they stopped—which then calculated how long it would take for the alcohol to leave the individual's blood.

"With a G1 or G2 licence, you can have no alcohol in your blood when driving a motorized vehicle, which includes your snowmachine," said Constable Hart. "A lot of the time you think you are safe if you stay the night at a friend's house and drive home the next morning, but you could still have alcohol in your system."

"All this is just something for you guys to think about," said Ms. Verboom. "We just want you to be careful."

In the next workshop Manitoulin Detachment OPP Constable Al Haner spoke to participants about wilderness survival.

"I've seen a lot of mistakes which have resulted in the police being called," began Constable Haner. "People getting lost on their sleds, not telling someone

where they are going, having a radio, or being prepared with warm clothing and emergency supplies. Think about how far you might have to walk if something happened to your sled and no one knew where you were and you had nothing to help yourself. No one plans for accidents like running out of fuel or smashing up your sled, but you need to be prepared."

Constable Haner stressed the importance of telling someone where you are going and when you will be back when you go out on your snowmachine. He also noted what great tools a cell phone, GPS and compass are.

He went through various situations with the students and talked about what they could do and how they could handle the situation. He also discussed key items to

bring with you when you go snowmachining that could save your life including a first aid kit, flashlight, lighter, ice picks and extra spark plugs.

Constable Haner then took the students outside and taught them how to start a fire in the winter using items they find outdoors such as birch bark for tinder and dry wood (on the bottom, inside of spruce trees).

In the afternoon, paramedic Monic Shaw spoke to the class and did a hands on workshop focused on trailside first aid.

The afternoon paramedic concluded with Brad Middleton of the Manitoulin Snowdusters discussing how trail permits work and what the permit money goes towards.

On the second day of the

snowmobile program, participants got to go on a trail ride across Manitoulin, enjoying the outdoors and even a lunch at Green Acres in Sheguiandah!

The fire department had giveaways and provided information on how to prevent a house fire by installing a smoke detector on each floor of the home.

Apryl Mayer and Aaron Wright, who started Manitoulin Fire Fund two years ago, specialize in after care for victims of a house fire by providing clothing and other essential items to carry a family through the first 72 hours.

Kathy McDonald of the Manitoulin Snowdusters had pamphlets and giveaways of water bottles and whistles to kids and adults alike.

Kathy Jewell of Kat's Pet Supplies, based in Mindemoya (who is an ongoing supporter of events hosted by the Rec Committee) had coats and other warm clothing items for man's best friend.

Dr. Paquette had information for the different services her practice in Mindemoya offers.

Mike Moore, project manager from Rainbow Routes (based out of Sudbury), along with Judy Day and Muffie MacIntosh, introduced the public to Trails 4 Life which includes urban poling, snowshoeing and cycling. They provide workshops in Sudbury, Espanola, Massey and Manitoulin Island and partner with the Sudbury District Health Unit to provide new physical activity opportunities to people over the age of 55 with the project. Ms. Day and Ms. MacIntosh spent time with several individuals, including this reporter, to demonstrate the correct way to walk while using the poles to obtain the best results. "One hour of walking," shared Ms. Day, "is the equivalent of 1,800 abdominal compressions (also known as crunches)."

Pulses celebrated at Debajehmujig 2016 Seed, Preserve Swap

MANITOWANING—The pulse is a beautiful thing. This year, Debajehmujig Storytellers joined the United Nations General Assembly in celebrating 2016 as the International Year of Pulses, focussing on pulses as part of the annual Seed Swap.

As near and dear to the heart as they are, these pulses have nothing to do with the pulmonary system that sends blood coursing through the veins, except most tangentially. The pulses referred to by the UN and Debaj are beans, lentils, peas and chickpeas, declared as the cornerstone of global nutrition for millennia.

As usual, Debaj took to the task by waxing theatrical, holding a pulses pageant that featured among its number the lentil, green beans, black-eyed peas and... jelly beans?

Well, the jelly beans were eventually disqualified for the sweetest of most obvi-

ous reasons, being a candy and not members of the pulse family.

"We felt the seed swap would make a great opportunity to highlight the important role pulses play in global nutrition," said Debaj Artistic Director Joe Osawabine. "We would have liked to see the coffee bean and the cocoa bean in the pageant as well but, well, they aren't pulses either are they?"

Debajehmujig Storytellers have a long history of incorporating humour and a distinctly Native tongue-in-cheek approach to serious subject matters and this occasion was no different, with pulses providing plenty of food for puns.

The bean is one of the three sisters of traditional Anishnaabe nutrition (along with corn and squash) and they have always played an important role in maintaining healthy lives amongst indigenous populations in the Americ-

as.

Pulses are a good source of protein. For instance, lentils offer double the protein per serving of quinoa and they are also an excellent source of fiber, containing four times more fiber than brown rice. Pulses are also rich in antioxidants, iron and folate and are a good source of potassium. As an added bonus, pulses are naturally free of sodium, cholesterol and gluten. In fact, the key message of the 2016 International Year of Pulses is that pulses are highly nutritious—their little seeds are packed with nutrients and provide a "fantastic" source of protein.

This year's Seed Swap featured the usual collection of heritage offerings, but also came with a new twist. People were invited to bring samples of their own preserves to trade with others.

"This is all in keeping with our positioning as a

land-based theatre company," noted Mr. Osawabine. "As Anishnaabe people we are solidly attached to the land, it is a part of us, and

what could be more fitting a celebration of those connections?"

The pageant took a hilarious swipe through all

things gastronomical, ending with a fitting tribute to the legume known as the green lentil.

Refugee Report

Fourth refugee family slated to arrive on Manitoulin March 15

 MANITOULIN—Three refugee families have begun settling into their new homes on Manitoulin Island, two in Little Current and one in Gore Bay, with word arriving Monday that the Mindemoya family is slated to arrive on March 15.

“As far as I know, all the children have started school already,” said Manitoulin refugee resettlement committee spokesperson Dr. Ben Quackenbush. “As of today there are four in high school and the rest have started in elementary school.”

One family member, who at 21 is barely too old to attend high school, was to register for upgrading at Cambrian College yesterday (Tuesday).

The process has been one of mutual learning as some of the simplest household items readily apparent to most Canadians (think likelihood of finding hot and cold water faucets in an eight-foot by 10-foot tent in a desert refugee camp) coming as a surprise to our newest Canadians. But according to the volunteers who are coaching them, there is no question the refugees are eager and quick to learn.

“The girls have been eager to take on the cooking,” said Little Current

committee spokesperson Linda Erskine. Variable heat on a modern electric range is a big change from cooking over an open fire and requires a bit of a learning curve as well. “They are picking things up quickly.”

The concept of snow days is another decidedly Canadian artifact that took a bit of explaining to the young students who were eagerly lined up for the school bus last week. Their disappointed reaction to the news that school (buses at least) was cancelled proved somewhat untypical for a Canadian student. When school is an almost un-dreamed of privilege, rather than a daily task, perspectives can differ.

Some of the refugee children have arrived just in time to take part in a school outing to Science North and it is difficult to decide who is more excited, the children or those volunteers who have stepped up to accompany them on the

jaunt.

One facet of the refugee's plight they have hopefully left behind are the death threats and the daily possibility of violence, both of which some of the family members have experienced before

their arrival on Manitoulin. That reality of their former life lays an unfamiliar layer upon the volunteers who

are trying to assist the refugee's settlement on Manitoulin.

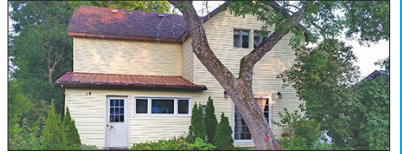
