Island-wide election roundup Municipal election sees many new faces on councils

MANITOULIN-While some municipal elections saw no major changes for the position of mayor/reeve or councils on Manitoulin Island, others saw big changes in the municipal elections held on Monday night.

Assiginack

In the municipality of Assiginack there has been a change at the top, with a new mayor having been elected.

Brenda Reid won the election, receiving 428 votes to 264 for longhad served as a councillor previously.

There was a total of 10 candidates running for one of four seats on council. Those candidates who will serve on council include Dwayne Elliott who received 472 votes, Janice Bowerman with 375 votes, incumbent Robert Maguire with 336 and Jennifer Hooper with 301. Other candidates included Dene Banger receiving 100 votes, Theodore Flikweert with 63, Christianna Jones 219, Frank Klodnicki with

time mayor Dave Ham. Ms. Reid 156, Maureen Marion with 156 and Cheryl O'Brien McCulligh with 171.

Billings

Billings Township incumbent councillor Bryan Barker was the only candidate who put his name forward for the position of mayor of the township, being acclaimed.

There were six candidates in the running for the four council seats. The new council will include Dave Hillyard with 381 votes, Michael Hunt with 359, Jim Cahill 301, and Vince Grogan with 186 votes. Two other candidates, Mike Larocque with 187 and Paul Darlaston received 186 votes.

Burpee and Mills

For the Township of Burpee and Mills incumbent reeve Ken Noland was acclaimed for another term.

There was an election held for the four council positions with a total of 10 candidates in the running. The four candidates who will make up council include Art Hayden who was re-elected with 123 votes, Kim Middleton with 120, David Deeg with 92 and Roger Morrell with 84 votes. Also in the running were Nicole Middleton who had 24 votes, Ed Wright with 63, Mike Wright 31, Melanie Blain with 22 and Steve Dinsmore with 15.

Wiikwemkoong claims to Islands in Georgian Bay leads to offer of Crown lands in reparation

OTTAWA—Northeast Town council received a letter from Alison McLaren, Indigenous Affairs senior negotiator for the Wiikwemkoong Island Boundary Claim, informing them that the province has concluded the formal Category C environmental assessment requirements for the boundaries claim, locally known as the Wiikwemkoong Island's Land Claim.

The claim includes several islands included in the Northeastern Manitoulin and the Islands catchment. The conclusion of negotiations does not directly impact the municipality or its assessment base, as noted by Northeast Town Mayor Al MacNevin during an October 18 council meeting.

The boundary claim, which involves both the Province of Ontario and the Government of Canada, as well as Wiikwemkoong Unceded Territory, centres on Islands in Georgian Bay and the North Channel which were never surrendered to the Crown, some of which were transferred to the Municipality of Killarney shortly after the amalgamation which created the Northeast Town in the late 1990s.

The Class EA focuses only on potential impacts arising from the transfer of Crown land to Canada to be set apart as reserve for Wiikwemkoong Unceded Territory. Alternatively, if this is not possible, the lands will be conveyed to a designate of Wiikwemkoong in fee simple, to be held in trust for the benefit of Wiikwemkoong. Meet the elected mayors, reeve named to lead Island councils

MANITOULIN—There are many new mayors and reeves joining the ranks of Island politicians this term. We caught up with several of the new, and seasoned, heads of council on election night to chat about the future ahead.

Reeve John Deforge

Newly elected Tehkummah reeve John Deforge said his first order of business will be to "do the township business.'

"All we need to do is to make the township work," he said, adding that can be done if council members leave their personal feelings at the door and concentrate on the needs of the community.

"You have to work together as a team," he said, adding that his experience in handling large scale construction jobs employing hundreds of people will hopefully transfer to the political stage.

Mayor Ron Lane

Ron Lane has been elected to serve in his third term of mayor of Gore Bay, beating out newcomer Maureen Armstrong for the top job.

"I'm obviously happy and very pleased to have been elected," he told The Expositor, "and that the majority of voters supported me. I'll do my best over the four years to get things done to make Gore Bay a better place. I look forward to working with the new council. There's only one member of council that I worked with before and that was Dan Osborne but I'm looking forward to working with everybody who was elected.

The mayor elected said he hopes to see the new council sworn in as soon as possible to begin the work of completing projects that have been started and working on concerns such as the Manitoulin Lodge, gaining new doctors and the housing shortage.

Mayor Brenda Reid

Former Assiginack councillor Brenda Reid won her bid for mayor of Assiginack on Monday night, ousting Dave Ham by 164 votes.

Ms. Reid is tasked with overseeing a largely new council, with only Rob Maguire being returned for another term.

"I look forward to working with them all," Ms. Reid told The Expositor Monday night. "I feel good and I feel confident." The mayor elect said she is looking forward to getting started right away.

"Councillor training is so important," Ms. Reid continued, "then we will move on to priorities and budgeting.'

Ms. Reid said she will encourage her council to write down all their priorities, with an eye to the budget, and then work together to see what can be accomplished in the short- and long-term.

A big believer in participation, Ms. Reid has plans to encourage as much committee involvement as she can with her new council.

"You're going to be hearing a lot from Assiginack," she told The Expositor.

As an interesting aside, when Mr. Ham was first elected reeve of Assiginack he defeated incumbent Herb Reid, Ms. Reid's late fatherin-law. When Mr. Reid was elected as reeve, he had defeated long-time Assiginack politician Hugh Mog-

Campbell Bay boat launch closed due to severe disrepair

EVANSVILLE—Local boaters are upset, as is Burpee and Mills council, that the Campbell Bay boat launch is in such bad condition it had to be closed.

"The Department of Fisheries and Oceans (DFO) is shutting it down, because the boat launch is not safe," said Ken Noland, reeve of Burpee and Mills. "We've been working for probably five years, at least, on this issue. They (DFO) had approached us asking if we wanted to take over ownership of the boat launch. But originally it had no access (the launch is surrounded by a Ministry of Transportation picnic park) and is land locked so you couldn't get from Highway 540 to the boat launch. But it is a mess—it's in poor condition; they wanted to give us a boat launch with potential liability. So, then DFO said they would consider giving us a grant to fix the structure, so we said okay, we will discuss this ownership transfer.'

"But seeing that it is a federal structure, the province has to sign

off on it, and it can take up to two vears for the province to give up rights on it (the access to the boat launch)," said Reeve Noland.

Dave Johnson, a local boater who uses the Campbell Bay boat launch told The Expositor, "this is probably one of the most used boat launches in this area, at least on Western Manitoulin. I spent

half the summer contacting (Algoma-Manitoulin) MPP (Michael) Mantha about the condition of the boat launch. The boat launch is owned by DFO, and now we got a newsletter from the township saying it is going to be closed.

During the week of October 17, DFO announced it would be clos-

ing the Campbell Bay boat launch due to its unsafe condition, the township October newsletter reads.

"It's not safe, it is in brutal condition," said Mr. Johnson. "Everyone around here uses the launch ramp. Fisheries and Oceans are not going to do anything with it. Hopefully, at some point after the ramp is repaired, the township can take it over."

Mr. Johnson noted the boat launch had been under water three years ago, due to the highwater levels and work was carried out to improve it.

However, "it is 100 percent unsafe," stated Mr. Johnson. "DFO should fix it and let Burpee

and Mills take it over."

Reeve Noland pointed out the township has been in contact with Algoma-Manitoulin MPP Michael Mantha on the issue. "We were told they need to have an engineer to do a survey on it to see what kind of condition it is in. Now we are waiting for the province to sign off on any claims to the boat launch, and then we can talk again about getting it fixed and the township can consider taking it over. This is not a dead issue, but I don't see the boat launch being in place next year. I know they will be closing it this weekend.'

LCPS principal raises Blake St. speeding concerns

LITTLE CURRENT—The topic of speeding drivers in Little Current has again raised concern with mayor and council, this time from the principal of Little Current Public School (LCPS).

At its October 18 meeting, council reviewed a letter from LCPS Principal Heather Pennie who asked council to consider l roadway signage telling ncreas

speed bumps to be installed within Blake Street's school zone.

"Drivers sometimes drive verv quickly down Blake Street, which is where our student pick-ups and drop-offs occur," Ms. Pennie writes. "The Rainbow District School Board has installed a drive-through parking lot area to help with the traffic flow and provide a place for vehicles to pull off the roadway, but parents have

traffic on the street, sometimes travelling at excessive speeds. This may be due in part to the location of the Tim Hortons which has increased vehicle traffic in the area."

This was the second meeting in a row that speeding had been raised, causing ČAO Dave Williamson to launch a report into what traffic calming measures are at council's disposal such as speed bumps, median barriers or increased signage. As an immediate solution, Mr. Williamson told The Expositor the municipality has ordered four 'school ahead' signs that include the speed limit on them to replace the existing signs on both Blake and Draper streets. Island municipalities need to get a handle on speeding

Parents of young children walking along the streets of Island municipalities have been reporting encounters with dangerously fast vehicles of all shapes and sizes.

Despite the Northeast Town having reduced speed limits on the roads within its built-up areas to 40 kilometres a few years back, apparently too many drivers have still not received the memo.

Northeast Town council members have reported receiving numerous complaints from their constituents on many town roads and, most recently, Little Current Public School principal Heather Pennie officially noted concern about vehicles travelling at high speeds in the vicinity of the school on Blake Street and asked for increased signage. Ms. Pennie suggested that speed bumps could possibly be installed in the school zone. Principal Pennie also noted parents are concerned about the high speed of vehicles through the area, despite the recent addition of a drive-through parking lot to assist with traffic flow on Blake Street. The manager of Little Current Child Care Daycare Services, also located in the elementary school with access from the Blake Street side, echoed Principal Pennie's concerns.

The problem of excessive speeders on local roads is not confined to the town of Little Current, or even just built up urban areas, as reports are coming in of excessive speeding on Townline Road in Sheguiandah and through the town of Mindemoya—it seems that anywhere that a driver can build up a good head of steam is being taken as fair game.

being issued (see the precipitous drop in Provincial Offences Act revenues reported over the past couple of years in the pages of this paper) and the alarming rise in anecdotal reports of speeding in Manitoulin's built-up communities. Who among us does not still instinctively step on the brakes when coming up over the hill into Espanola, former site of one of Ontario's most best known speed traps (Espanola has since moved to OPP enforcement).

Although the Tim Hortons outlet located at the end of Blake Street at the juncture of Highway 6 is referenced in Ms. Pennie's letter to council as a potential source of increased traffic on that road, the popular donut emporium and purveyor of coffee cannot be singled out when it comes to the many other Little Current streets where local residents also report increased speeding.

Island communities have stepped up to purchase radar signs to alert drivers to their speed and these seem to have had some impact, although those signs have not completely alleviated the issue and much more needs to be done to protect and serve our communities.

There are plenty of options available to assist in tackling the problem, one of which is stronger enforcement, but there are many others, some of which are of relatively low cost and which do not involve the challenges of installing speed bumps. We need to see movement on this issue from all of our municipalities before someone gets seriously injured.

It is hard not to make a connection between the low rate of tickets

To the Expositor:

Hello spooky story readers, welcome back to another Halloween tale based on Manitoulin Island. If you recall, two years ago we detailed the story about the Man in the Bridge. Last year, we discussed some of the terror within Halcrow House at Ten Mile Point. For this tale, we're going to move over to the Mindemoya region where my family has about 200 acres of hunting land.

What's particularly interesting about this part of the Island are some of the rock formations you can find there. Rocks you say? Yes. rocks. I'm talking about the alvars of Manitoulin. You will know you've hit this type of ecosystem because the ground looks like flat limestone pavement with slabs cut into it. The slabs are called 'clints' and the spaces between them are called 'grikes.' The grikes, or the cracks in the ground, are what this story is all about.

I've often told my children to be wary of such cracks because you don't really know what resides in them. My oldest son Jonah didn't really buy into the whole idea, citing the fact that often times these cracks were filled with soil and vegetation. That was until we came to a grike that he couldn't see the bottom of. To test how deep it was, he threw a

stick down inside of it. We never heard it hit the bottom.

My youngest son Keith would often run up ahead of us too far and I asked him to mind the cracks. After we found the bottomless crack in the ground, he stuck a little closer to Dad. "Why do you think there is something down there, Dad?" They asked. I would tell them the tale of the old hunter. You see the old hunter would often hunt deep within the area of the grikes but he was always wary of them. The story passed down through the generations was that something changes about the grikes as you approach nighttime. Something wakes up.

The old hunter typically heeded this advice well except for one time when he started to doze near dusk. He woke with a start just as the sun was setting and rushed to leave the cracks in the ground. He was almost out when he tripped at the bottomless grike. As he sprawled forward and stumbled to the ground, he looked back to see what had tripped him. He saw what caused his fall and let out a 'yipe' as he scrambled to get away. The old hunter returned to camp and to his fellow hunters white as a sheet. They asked him what was wrong, but he would not say. He knew well that they would never believe his story. As to what the old hunter saw, your guess is as good as mine. I just know the story and heed it well. I have passed this story down to my own children and they will likely pass it down to theirs. We know not what resides there but beware the cracks in the ground!

Pauline and Wayne Martin

At the tender age of 13, she began working at Merritt's hotel in South Baymouth. Wayne came into her life after they met at a local dance. Her subsequent work years were with the Toronto Workmen's Compensation Board. Later, back on Manitoulin, Pauline worked at the Wigwam giftshop before taking on the caretaker job with Wayne.

"My grandparents are Mathew and Jane (Hillson) McCauley," Pauline begins. "Jane was born in the town of Michael's Bay where a fire later forced them from their home. They moved to a log house in Tehkummah. Their son Pete, my father, had gone west to work in the logging industry. He met and married Jean Livingstone of Ladysmith, British Columbia." Pauline was born to Jean and Pete McCauley on April 26, 1940, in



school and someone on the other side, had to catch it." "At the No. 7 Slash School, Mrs.

Ruby Coultis was our teacher. I liked spelling but still hated math. I tried my best, but I was never going to excel because I preferred to be riding my horse. We walked two miles to and from school each day. In the winter, some days were stormy. My siblings and I bundled up and walked quickly to keep warm. Once Wilfred Coultis, our teacher's husband, gave us a ride on his sleigh. Dad finally got a car, but it wasn't big enough to get all of us in. For short trips, we used a sleigh built by Bill Bowerman. We harnessed the dog and he could pull us short distances.

"We helped where we could, leading the cattle to a field or doing housework but inside work was less appealing because we were inside. I was 13 when I cleaned rooms for Merritt's Motel in South Baymouth. They had a very strict cleanliness policy. There was a constant porridge pot on the stove for staff and each day more cereal was added. Sometimes the whole pot would be sour, but the owner had no sense of smell, so couldn't tell. Suppers were equally sparse. We got the outer leaves of the cabbage or other left-over vegetables and meat." After two years, I got work with the Ferry Lunch Restaurant, on the terminal dock. We served lunches and simple meals.

"I spent the summer of 1956 at the Black Rock Resort on South Bay, cleaning cabins and also in Kagawong doing housekeeping for Austin Hunt. I had met Wayne a year earlier at a Tehkummah dance. He had another girlfriend at the time, but when they drifted apart, we got together. He had his own car and he sailed." Wayne's parents are Clarence and Margaret (Haner) Martin. He was born in the Mindemoya Hospital on a stormy March 10, 1939. Roads were not cleared at the time, so he was brought home in a horse and cutter, for the two-hour trip. Wayne came from a long line of Martins who had come to the

Island in the mid 1800s. Wayne continues: "I had four siblings, two sisters, Girda and Maxine and two brothers, Lloyd, and Floyd. Lloyd died at 16. Mother was 49 when she passed away in 1949. She had asthma and had been treated with a 'medical smoke' to clear her lungs. I was 10. There was a wake in the house before the coffin was taken to the church for the service. That was a tough time for us all. After mother died, two older sisters would bake for us in their own homes. Dad would bring them ingredients like flour and raisins. Our grandfather, Tom Martin, had suffered through a fire and had been severely burnt. His face was raw and blistered and his countenance gave one a start. He was always very friendly, keeping peppermints in his pocket for us but you had to blow the chaff off first," Wayne offers, smiling. "He died the same year as our mother." "After dad remarried in 1954, we had seven living in the house, Raymond, Lyle, Donna, Irene, Floyd, Wayne and Dad. I liked school but hated that I lived right across the street from it. I had no excuse to miss even a stormy day. The teacher was always there. Floyd and Donna rode the school bus to the High School in Mindemoya and in 1956, I joined them. It was quite a change after the oneroom schoolhouse. There were two Grade 9s. I luckily got into the

main class because the other class was held in the basement of the community center. Math, science, and history were my favourites."

"I finished half of Grade 10, realized I wasn't heavy enough for INCO underground work, but I could make good money working at the acid plant in Cutler. They needed carpenters to construct scaffolding. By the spring of the following year, at 18, I was working on the big lakers. Nausea was making this work less palatable, and our money could only be spent when the 'Bun' boats tied up next to us. They offered smokes, shirts, guns and stamps for letters."

"We experienced serious difficulty only once, when the big dock cable, used to tie up the 600-foot boat, owned by Upper Lakes Transportation, got washed overboard. It got tangled in the propeller and the motor. It took many hours to fix that. One summer we had a load of train wheels to deliver to Chicago. We tried to stay clear of these heavy wheels. A shifting load during a heavy wind, could have injured us and sunk the boat." Another time, Wayne was wheelsman. "The boat was light, and we were working against the wind." Wayne saw a light on shore and expertly held the course until the wind died down.

"Many of our boats were Canallers, about 350 feet long, used to haul grain from Thunder Bay and Toronto to Quebec and

completely on my own. I was so scared. I sat down at the UIC (Unemployment Insurance Commission) office and after a little while, started to cry. 'What's wrong?' a nice lady staffer asked me. I told her my story and she bid me follow her. She called someone then turned to me and said, 'I have a job for you. Please wait on this corner for the streetcar and stav on it until it goes for a loop, then get off at this street.' Surprisingly, I found that destination and got the job. I had borrowed Peg's glasses so I could read the signs and get off at the right stops. I was making \$32.50 a week at the Workmen's Compensation Board after making \$11 every two weeks on UIC. I was rich."

Wayne and Pauline continued to date, and they were married on Tuesday, July 14, 1960. "I bought her a nice ring, and she couldn't refuse," Wayne shares, smiling. The ceremony was held in St. Andrew's by the Sea United Church in South Baymouth. Wayne Smith was the minister. Uncle Wilmer gave Pauline away as Dad was away for work. A lively reception was held at the parental home. Then it was back to Toronto to the upper floor of a rented house. Pauline was back at WCB, and Wayne was now driving buses for Toronto Transit.

The couple had three children, Christine, Steve and Anita. "When I was expecting Christine, I was surprised that the Toronto pharmacy allowed me to charge some baby items that would be paid when Wayne got paid. That worked well for us. "In 1969, my father died of a heart attack. He was working for Ontario Hydro. Our mother then started to work for some of the tourist camps: the Buckhorn Hotel, Northern Aire Lodge and Timberlane Rustic

and called the authorities. Luckily, the train always backed up to McKerrow from Espanola."

The family arrived to a snowy, cold Manitoulin. "All the kids were still sick, and father's serious back operation confined him for a week in the Mindemoya Hospital. At this point, mother would have easily jumped right back on a train bound for Vancouver. We lived with an uncle for a few months, then rented a house in South Baymouth before buying a small farm near Tehkummah in the spring of 1949. There was no running water and no hydro. Our last sister, Susan, the only Haweater, was born on the Island. I loved the farm and the animals.

Duncan. She was the third child with siblings: Pat, Peg, Nancy, Molly and Peter.

"In the mid-1940s, planes flying overhead spooked our mother into turning off all lights and closing the curtains. The war was over, but it could have been a last stand for the German Luftwaffe. My dad worked hard in the lumber business until a pile of logs rolled on him, severely injuring his back. His spinal fusion was one of the first in Canada. He wore a cast for six months. That injury inspired father to return to Manitoulin." The children weren't feeling well when the family got on a bus to the ferry on Vancouver Island. The last leg of that train trip across Canada in 1948 is a strong memory. Dad, Pat and I got off the train at the McKerrow station to get some milk for the baby. The train left while we were in the store. We panicked It was a good life. Mother was a great cook too."

"An early memory on Manitoulin was our grandmother arriving at our door in Tehkummah, with her apron on. carrying a cream pail. 'Come and pick strawberries with me,' she had asked." Sadly, Grandmother died in 1949 when I was just seven. At school, Mr. Nelson Little was a kind teacher but I was afraid of teachers. The instructor in Duncan, British Columbia had asked me to share my answer to a math question on the board. The answer was wrong. The teacher hit me, and all the children laughed. I vowed never to answer a question again. But this was Manitoulin and I had to trust the same would not happen. Games were fun. They included 'red light, green light' and 'Anti-I-Over' which had us throwing a ball over the outhouse or the

Pauline and Wayne wrote many letters to each other, and Wayne visited when he could. When Wayne's dad died in 1959, Wayne came home and worked on the farm until it was sold in the spring. Then Wayne headed back to Toronto and worked in a gas station and made deliveries for Eaton's. "My cousin Russell Moody, a police officer who regulated downtown Toronto traffic between Eaton's and Simpson's, recognized me one day and slapped my elbow when I drove past him. It was nice to have family nearby."

Pauline explains: "My father had sent me to Toronto to broaden my horizons before marriage. My sister Peg lived there and worked at a local Toronto Credit Union. She had been so brave to come alone to the big city. I was 17, fresh off the Island. One morning Peg said, 'Let's go downtown and get a job.' She dropped me off on Bay Street, directing me to go right to left hand."

"In 1978, mother, Wayne and I went west to visit her mother, Marjory Livingstone in Vancouver. They hadn't seen each other for 20 years. Grandmother Marjory lived in a small apartment. When the two saw each other, they began to dance in a circle and sing, 'Little Green Valley,' a song they had shared decades ago. Mother also saw her two sisters, Vi and Gladys. Vi knew the game warden and was able to purchase some wild salmon and king crab. We had a feast, with enough for breakfast the next day.

"One day I was sitting in the sun at my mother's place on Manitoulin when Wayne and I decided to look at a few houses, one of which was this empty house. We made an offer, bought our house in 1981, then moved to Manitoulin. My brother-in-law came down to drive the car back and I drove the moving van. Two of our children were on their own by

There were elections for the position of reeve of Tehkummah Township and for the four seats on council. John Deforge has been elected as reeve, having received


a total of 281 votes to 83 for Eric Russell. There was a total of seven candidates in the running for



Province approves Island detachment board framework

by Tom Sasvari MANITOULIN—While the province of Ontario has approved the proposal for the Manitoulin Ontario Provincial Police (OPP) detachment board framework, implementation of the new board will not take place for at least a year.

"The province has accepted our police board proposal," confirmed Ken Noland, Reeve of Burpee and Mills and chair of the Manitoulin Municipal Association (MMA), last week. "They didn't accept our original proposal or second proposal.

"So, we reduced the number of representatives from the municipalities," said Mr. Noland. "Tehkummah and Assiginack agreed to have one rep between them and Burpee and Mills, Gordon/Barrie Island, and Cockburn Island will also have one rep between them. Gore Bay, Central Manitoulin, Billings and NEMI would have one representative each on the board

'Originally, everyone wanted a representative on the board, but with provincial appointees as well there would have been about 13 people on the board" said NEMI Mayor Al MacNevin. "No one wanted that big of a board. Then Ken (Noland) worked with the municipalities to look at something quite a bit smaller in numbers.

Sarah Caldwell, acting assistant deputy minister of the Ministry of the Solicitor General told the MMA in a letter dated October 12, "thank you for submitting your proposal related to the detachment board framework for the Manitoulin (Burpee and Mills) Ontario Provincial Police (OPP) detachment to the Ministry of the Solicitor General (the Ministry),'

"The ministry is currently working with municipalities and First Nations to finalize incomplete proposals by November 30, 2022. We have reviewed your submission and determined that your proposal meets all requirements, and no further action is required on your part at this time," wrote Ms. Caldwell.

Mr. Noland pointed out, "we still have no idea of what all the costs are going to be for this all of this."

Mr. MacNevin noted as well, "Yes, the approval of the proposal is good news, but it might not be implemented until the end of 2023 or later."

'Maybe the province listened to the municipalities about not implementing this until after the municipal elections, with new board members having to undergo training (as members of the boards)?" suggested Mr. Noland.

Ms. Caldwell wrote in a letter to heads of council and First Nations chiefs on Manitoulin October 4, "I am writing to share an update on the Community Safety and Policing Act, 2019 (CSPA), and the new Ontario Provincial Police (OPP) detachment board framework under the **CSPA**

Al Boyd, chair of the Manitoulin Community Police Advisory Committee (CPAC) said, "everything is still all up in the air. The last time our committee met we said we would remain status quo until the new boards are set up.' He pointed out questions remain on the costs involved, (and who will be covering these costs,) and that extensive training is going to be required of police board members.

"I think the ministry just wants to remind us this is going to happen," said Mr. MacNevin. "They have never addressed the issue of costs involved, for instance if honorariums are going to be provided for board members and who will be responsible for these costs.

Brent Ross, spokesperson for MSG told The Expositor, "OPP detachment boards will be required to have community (public) representatives in addition to council members, which may include members of First Nations who receive OPP policing in the detachment. First Nations may participate in OPP detachment boards, at their discretion, either as a community with policing provided directly by the OPP, or to represent off-reserve membership with the OPP detachment. If a local First Nation that is policed by a self-administered First Nations police serv-

Councillor Jim Ferguson brought up the topic of a return to in-person meetings following a request from a ratepayer that this should occur so they might attend "with the rest of us." Councillor Ferguson said it didn't personally matter to him.

Council has been meeting via Zoom since the start of the pandemic.

Councillor Bill Koehler said he believed this decision should be left to the new council when they are sworn in next month.

Councillor Barb Baker noted that Sudbury District Health Unit has a COVID risk assessment that states that face-to-face meetings

are not recommended until the assessment moves to 'low.' As of October 11, it was at 'high.'

Councillor Michael Erskine said if there are any of members council uncomfortable with the idea of meeting face to face, he's okay with remaining status quo with Zoom. He also suggested council might want to explore moving to a hybrid system of meeting.

Councillor Al Boyd said he was ready for a return to in-person meetings but was "good either way."

Councillor Bruce Wood said he felt this decision should be made by the newly elected council.

Councillor Laurie Cook said that while she's happy to go back to in-person, she thought it "probably wasn't advisable" and should also be left to the decision of the new council. She also thought a hybrid model was a good idea.

"We really need to have a state-of-the-art room to make it (hybrid) work," Mayor All MacNevin advised. "We would need time to get set up properly."

Government Dock washroom tender

Tender results were opened October 7 for new washroom construction at the Sheguiandah Government Dock.

There were three tenders received: Adam Callaghan, \$149,000 (incl HST); Le-Five Masonry, \$81,134 (incl HST); and Tony Dickson, \$116,390 (incl HST)

It was recommended to council that the tender from Le-Five Masonry be accepted. The work is 100 percent funded with a \$100,000 government grant.

Councillor Ferguson asked about sewage treatment and water. CAO Dave Williamson explained that the washroom would use un-treated lake water and that there is a sewage holding tank already in place from the previous facility.

Speeding in Liftle Current

Councillor Bill Koehler raised the issue of speeding, specifically on Wilson and Draper Streets with several residents complaining to him about the problem. Councillor Koehler said he is hearing from residents who are wanting speed calming measures in place.

Councillor Michael Erskine noted that Meredith Street could also be added to the list of streets of concern.



waiting on them to come in and they will be put up immediately.'

Councillor Bill Koehler asked for specific research on speed bumps, such as those located on Sudbury's South View Drive.

Amanda Roy, supervisor at Little Current Child Care told The Expositor daycare staff also has serious concerns about the rate of speed some drivers are travelling. The busy daycare, located at LCPS, also uses Blake Street as its entry and exit point.

"We see people speeding up and down Blake Street daily and it is dangerous," she said. "We're happy to hear that this issue is being addressed by NEMI council because it worries us as well."

When contacted for comment after the meeting, Ms. Pennie said she was pleased "that mayor and council are giving our suggestions consideration. Safety is certainly a shared concern. As a caring community, we can never be too safe when it comes to our children and families.'





...continued from page 1 to underscore one particular aspect that captured my attention, and that is her commitment to leave behind a better system than the one that existed when she entered it at the start of her career," said Ms. Dowdeswell.

'Marian, your creation of a program that provides free legal representation to child survivors of human trafficking is but one example of how you've championed the under-represented and underserved throughout your career," continued Ms. Dowdeswell.

"As a dedicated leader, you've recognized the urgent need to nurture the next generation, sharing what you've learned with new lawyers, social workers and students, those who will sustain us through the challenges ahead. Your leadership will ensure improved outcomes, not only for clients today, but no doubt, for those encountering the justice system for years to come," said Ms. Dowdeswell. "You have also led by example and helped advance the cause of reconciliation in Ontario, as the first Ontario Children's Lawyer to implement mandatory Indigenous cultural competency, antiracism, and anti-colonialism for your staff." "As the representative of His Majesty The King in Ontario, Marian, I offer you my warm congratulations and best wishes and thank you for your service," said Ms. Dowdeswell.

Ms. Jacko is the acting Assistant Deputy Attorney General of the Indigenous Justice Division of the Ontario Ministry of the Attorney General. She previously served as acting Assistant Deputy Attorney General of the Victims and Vulnerable Persons Division in the Ministry of the Attorney General, as well as the Children's Lawyer for Ontario, becoming the first Indigenous person appointed to that role. Marian has also acted as legal counsel in the Motherisk Commission and for the Ontario Ministry of Attorney General.

One of the many people who supported nominating letters for Ms. Jacko's award was Ontario Regional Chief Glen Hare. "We've been talking about this for a long time, of nominating Marian for this type of award. Her deputy chief of staff worked alongside her. We supported her nomination.

"I was still chief of the M'Chigeeng First Nation when I first met Marian. I was in Toronto for a hearing concerning a member of the community. She met us at the courthouse, and we immediately connected," said Regional Chief Hare. "In the story she told at her awards ceremony she talked about her parents and the positive influence they had on her, and her career which she said was to be a funeral director. She changed careers with their support."

"Now look how far she has gone and how she has helped so many people," stated Regional Chief Hare. "She is now the acting assistant deputy attorney general of the Indigenous Justice Division of the Ontario Ministry of the Attorney General. But you wouldn't know all that she has accomplished. Marian is still a very grounded person.'

"This award is very much deserved," stated Regional Chief Hare.

Ms. Jacko, who also received supporting letters of recommendation from Wiikwemkoong then Unceded Territory Chief Duke Peltier and others said, "It is an amazing honour, and I am very humbled, thankful and appreciative

"It was a really nice evening, very formal and I was so pleased to have an hour with the Lieutenant Governor to sit and visit. It was a beautiful evening. said Ms. Jacko.

In the reading of Ms. Jacko's citation for the award it was stated in part, "as a lawyer trained in both Anishinaabe and Canadian Law, Marian endeavours to amplify the voices of historically marginalized communities and vulnerable people in Ontario. Marian's vision and distinctive leadership style, rooted in the Seven Grandfather Teachings of the Anishinaabe and informed by the Teachings of the Medicine Wheel.

development decisions are not assessed as part of the undertaking to transfer the lands, as the future use of the property is not assured at the time of transfer.

The official definition of the Wiikwemkoong Islands Boundary Claim is "a land claim relating to the islands off the eastern shore of Manitoulin Island. Wiikwemkoong Unceded Territory asserts that its rights and interests in and to these islands under the Treaty of 1836 have never been ceded or extinguished."

Through the settlement process, provincial Crown land within the area of the boundary claim and alternative provincial Crown land on the mainland and Philip Edward Island and surrounding islands, are being proffered as replacements for patented lands (privately owned) that cannot be returned to Wiikwemkoong

Buzwah Variety owners Rick Leedham and Dawn Marie Jacko are hoping to see a record number of pumpkins carved up by the community for Pumpkin Inferno. Last year there were an impressive 150 pumpkins, double from the year before!

Unceded Territory.

The selections of alternative provincial Crown land on the mainland and Philip Edward Island were influenced by a number of factors, including their proximity to Wiikwemkoong Unceded Territory's Point Grondine Reserve, proximity to infrastructure for community development and the historical presence that Wiikwemkoong Unceded Territory has maintained in the area.

The lands may be transferred to the Government of Canada to be set apart as reserve upon request of Wiikwemkoong Unceded Territory, but band leadership has indicated to The Expositor in the past that there is an intention to keep a portion of land on the Highway 17 corridor outside of the reserve process so that it can be utilized for commercial purposes.

Ms. McLaren noted in her letter that "although Ontario has concluded the formal EA process for the Wiikwemkoong Islands Boundary Claim, we are committed to continuing to update the Municipality of Northeastern Manitoulin and the Islands on the Wiikwemkoong Islands Boundary Claim negotiations as they proceed to settlement."


"Hockey has a long, proud history "Hockey in Wiikwemkoong, in Mnidoo Mnising and across our communities in this land," said Ogimaa-





Fall walleye index netting completed on L. Mindemoya

MINDEMOYA—The Ministry of Natural Resources and Forestry (MNRF) conducted its fall walleye index netting (FWIN) program on Lake Mindemoya last week.

Wayne Selinger, biologist with the MNRF explained "MNRF began setting nets on Sunday, October 16," and was completed on October 20.

"The main objective of an index netting survey is to assess the relative abundance of a fish stock and provide other biological measures or indicators of the target population's status," explained Mr. Selinger. "For FWIN, the goal is to determine the status and conduct an assessment of the walleye population on Lake Mindemoya."

Index netting uses gill nets, which kills the fish in order to fully study the walleye, including its age which is measured through the fish's ear bone, called otoliths.

The ministry last conducted FWIN in the fall of 2017. Mr. Selinger added, "once the survey is completed, the ministry will analyze the data. The ministry doesn't have an estimated date for completion at this time."

Town of Little Current construction boom currently underway

LITTLE CURRENT—The Northeast Town, specifically the Town of Little Current, is seeing yet another recordbreaking year of construction in 2022, with several new builds, and construction in general, currently taking place in Ward 2 of the municipality.

As of October 12, the Northeast Town had issued 73 permits and five renewals in 2022, 12 of which are for new residential construction, two for multi-residential, seven new seasonal dwellings, eight new accessory buildings and two new commercial/industrial builds. Eight of those new build permits were issued for Ward 2, or the Town of Little Current.

In one month, September to October, the municipality has issued \$21,496 worth of building permits with a construction value worth \$1,754,000. Year to date, \$131,746 in building permit fees have been charged by the municipality for construction worth \$10,723,000.

Chief Building Officer Rick Armstrong tells The Expositor this is one of the busiest years ever for new construction in the municipality.



...continued from page 3 engineers (Tulloch) and the ministry and a mitigation measures plan was presented by the engineers, assuming Blanding's turtles are present in the boardwalk area but would be protected (fencing). The plan was approved earlier this month and the work on the boardwalk began mid-October, said Ms. Carr. "It was in the ministry hands, and until we received their permit approving the mitigation plan, we couldn't go ahead.'

"There has been a lot of public interest in this project, but as we have said previously, we couldn't proceed with the work until we had the work permit." She pointed out the town had received funding for the project FedNor and the Northern Ontario Heritage Fund Corporation NOHFC for this and other projects.

Gore Bay received funding to upgrade its waterfront and boardwalk to attract more tourists and, in turn, increase spending at local businesses. Specifically, the funding was to be used to construct two bridges on the boardwalk, pave the front parking lot of the Harbour Centre, an arts incubator and museum hub, landscape the shoreline and install educational signage, flooring and install a chairlift to enhance accessibility into the centre's third-floor museum.

For the boardwalk, town council decided to go with option one; the board that crosses the creeks could be replaced completely from end to end with a helical pile system.

Several different tenders have been let for this; Tulloch Engineering, Pier Pressure with local contractor Andrew Preyde, with cement provided by McCann Concrete. The

helical piles were to be drilled last week, with all of the work to be done this fall, prior to the winter season

The shoreline work was carried out by H and R Noble Construction and several local contractors, while Beamish will be carrying out the Harbour Centre parking lot paving project this fall. A Toronto based company which specializes in commercial chairlifts, will be installing this structure in the harbour centre. And advertising for tenders for flooring have just gone out for bid.

Family and friends of Captain Clifford Morrison are heartbroken with his passing at the age of 84. Cliff was married to Julie (nee Sinclair) for 43 years. She adored him. He was the proud father of Jennifer (Ceri), Jeff (Carol), Cathy (Ron), Scott and Jane (Bruce). He was loved by grandchildren Carly (Jamie),

Kelsey, Christopher, Sydney, Paige, Elaine, Logan and Justin, and great-grandchildren Ivy and Ronan. Cliff was predeceased by his father Angus (1962), his mother Violet (nee Duxbury, 1996) and brother Gilmore (Ruth). He is survived by his loving sister Sharon (Glenn) and brother Rod (Joyce), and many devoted nieces and nephews. Cliff was a kind and soft-spoken man, loved and admired by everyone who knew him. He was born and raised on the Manitoulin Island until the family moved to Amherstburg when he was 10. The Island drew him back, and he spent his summers there for 32 years. As a tug captain himself, Cliff was licenced in both Canadian and US waters, working on the Detroit River and Great Lakes until he retired in 1998. He made many small wooden boats for his nephews, and later in life, he began to make detailed models of tugs and ships - working out the scale and measurements from original plans, fashioning the parts from wood and found materials. He donated some of these models to organizations such as the Marsh Collection Society in Amherstburg and the Red Schoolhouse Museum in South Baymouth. Children always loved Cliff for his gentle nature and twinkling humour, teaching them, for example, that it is acceptable to swipe a finger through the icing on an untouched cake. He liked to tell family stories, and he remembered his Grandma Annie Duxbury with great love. He was unendingly patient, doing everything with meticulousness and precision, whether it was fileting small lake perch or painting lettering on the side of a tug. 


